Fool-proof Relations: The Search for Anglo-American Naval Cooperation during the Chamberlain Years, 1937–40 by MALCOLM MURFETT

This book reveals the background to and development of Anglo-American naval relations throughout the Chamberlain premiership and the various attempts that were made during this period to extend and broaden the existing level of cooperation between the two governments in the hope that it might be used for politico-strategic purposes.

In studying the many official and unofficial approaches that were made to the Americans on the subject of foreign and naval policy, this book illustrates the divisions which existed between leading members of the British government over the question of a Far Eastern naval strategy and the relative importance of Anglo-American relations and shows the lack of a truly consistent and realistic policy on the part of both.

Whatever achievements were made in naval relations between the two countries, however, many other far more potentially important schemes for strategic cooperation were either neglected or declined. In examining the proposals that were made, this book reveals the factors which lay behind the catalogue of failures and wasted opportunities.

Social Change and the Chinese in Singapore by CHENG LIM-KEAK

This book examines the various types of registered Chinese associations in Singapore, founded mainly on the principles of dialect, place of origin, kinship and trade. These associations which emerged after the arrival of the first Chinese in Singapore, mushroomed and strengthened during the Colonial era.

Chinese society in Singapore is seen as consisting of various  $b\bar{a}ngs$ , the word denoting a Chinese politico-socioeconomic grouping based principally on a dialect. The author explores how the  $b\bar{a}ng$ -structured Chinese society in Singapore developed, their social and economic ramifications, and how they have been responding to the impact of the process of modernization unleashed since 1959.

The hypothesis of this study is that the Chinese  $b\bar{a}ng$ -structure was a product of British colonial policy of divide and indirect rule, facilitated by dialectal differences, competition and exclusion that prevailed in the formative decades.


