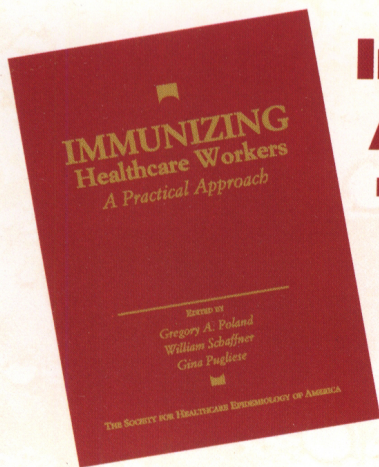

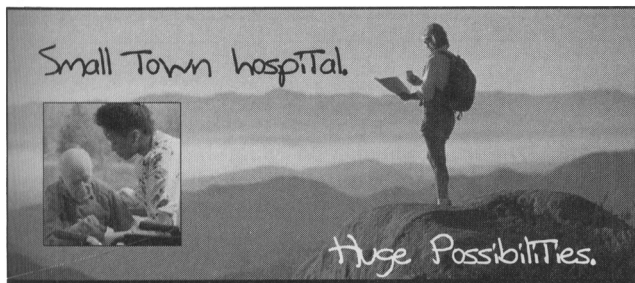

The Department of Internal Medicine, Faculty of Medicine, University of Manitoba, and the Winnipeg Regional Health Authority Medicine Program invite applications for a geographical full-time, contingent position commencing September 1, 2002. The selected candidate will be responsible for the medical direction of the Infection Control Program at the St. Boniface General Hospital, a 550-bed tertiary care teaching hospital affiliated with the University of Manitoba. At least 30% of the individual's time will be spent in scholarly activities. The successful candidate will participate in attending on the Infectious Diseases Consultation Service for approximately three months yearly, as well as the Outpatients Infectious Diseases Clinic for one half day per week in the Ambulatory Care Facility. In addition, the individual will be expected to attend for one to two months yearly on the general internal medicine clinical teaching unit. There will also be responsibilities in teaching of undergraduate students and postgraduate residents, as well as participation in continuing medical education sessions, both internal and external to the University. The candidate will participate in the supervision and direction of the clinical and academic work of residents and fellows who engage in the care of patients, the interpretation of diagnostic tests and the presentation of clinical and scientific data to others of the medical community. In the role of Director, Infection Control Unit, the individual will be responsible to the Head of the Department of Internal Medicine, University of Manitoba, and St. Boniface General Hospital, and to the Head of the Section of Infectious Diseases, University of Manitoba, and St. Boniface General Hospital.

The applicant is expected to engage in clinical and laboratory research projects of their own initiative or collaborative studies as well

as other scholarly pursuits directed towards increasing medical knowledge or enhancing medical education.

Candidates must have senior specialty qualifications in Internal Medicine and Infectious Diseases in the country of current practice and be eligible for registration with the College of Physicians and Surgeons of Manitoba. Certification in Internal Medicine and Infectious Diseases by the Royal College of Physicians and Surgeons of Canada is preferred. The applicant must have additional training in Infection Control and previous participation in Infection Control research.
