URBAN CHANGE IN CHINA Politics and Development in Tsinan, Shantung, 1890–1949 DAVID BUCK

Students and scholars of Chinese history, economic development, urbanisation, and social history will welcome this, the first full examination of a major Chinese city in more than twentythree years. David D. Buck describes how politics adversely affected the process of modernisation in Tsinan, Shantung, and in so doing illuminates many of the causes of China's political and economic problems in the period prior to 1949. Since the founding of the People's Republic of China, the ideas of Mao Tse-Tung concerning the revolutionary potential of China's peasantry have focused the attention of scholars on the nature and causes of rural immisersation in China. Chinese development policy since 1949 has further increased this interest because it has placed greatest emphasis on the continuing revolution of the rural sector. Yet, prior to 1949, it was not the countryside but the city to which most observers, both Chinese and foreign, looked for the beginnings of China's modernisation.

HEAVEN, EARTH AND MAN IN THE BOOK OF CHANGES Seven Eranos Lectures HELLMUT WILHELM

The I Ching, or Book of Changes, has long been thought of by scholars as one of the most important and complex works in the history of Chinese culture. It was the first of the Five Confucianist Classics and served as the well-spring of both Confucianist and Taoist thought. Following in the tradition of his father, Richard Wilhelm, who made the best known and most respected translation of the I Ching, Hellmut Wilhelm has come to be regarded as a pre-eminent authority on the Book of Changes. In these seven lectures, he carried forward his inquiry into the significance of the I Ching, both as a manual of divination and as a work of philosophy. These lectures were originally delivered between 1951 and 1967 at the Eranos conferences of scholars in Switzerland, and six of the seven papers appear in English for the first time in this volume. The aspects of the I Ching explored here include the concept of time; the creative principle; human events and their meaning; the "own city" as the stage of formation; the interaction of heaven, earth and man; wanderings of the spirit; and the interplay of image and concept.

CHINESE POLITICS AND THE CULTURAL REVOLUTION BYUNG-JOON AHN

One of the most important periods in Chinese politics, from the launching of the Great Leap Forward to its culmination in the Cultural Revolution, is analysed from a unique perspective. Although this book focuses on events occurring between 1958 and 1966, its scope covers the entire range of Chinese politics from 1949 to 1976. Using a wide range of sources, Professor Ahn explains the dynamics of Chinese policy processes that led to the Cultural Revolution and how Chinese leaders have shaped and been influenced by it. An exploration of the major conflicts that arose in the Chinese policy process helps to explain why Mao and his supporters chose to violate established patterns of policy formation in creating the Cultural Revolution, and enables the reader to understand the aftermath of the Revolution by explaining major causes and effects of the political conflicts surrounding it.
