#### Contributors

CHRISTOPHER CLAPHAM is Professor of Politics and International Relations at the University of Lancaster. His most recent book, *Transformation and Continuity in Revolutionary Ethiopia*, first published in 1988, appeared in a revised edition in 1991.

REGINALD CLINE-COLE has joined the staff of the Centre of West African Studies at the University of Birmingham (UK), after teaching for many years at Bayero University in Nigeria and more recently at Moi University (Kenya). Among his publications are Woodfuel in Kano (which he co-authored in 1990) and the jointly edited Perspectives on Land Resources Administration and Development in Northern Nigeria (1987).

BILL DERMAN is Professor of Anthropology and African Studies at Michigan State University. He conducts research on natural resource management systems and has written on river basin development in West Africa. He is engaged in a study of the ecological and social consequences of development intervention in the Zambezi valley.

ANNE FERGUSON is Assistant Professor of Anthropology and African Studies at Michigan State University, and researches on farming and fishing systems in Malawi. She is co-editor of Culture and Agriculture and The Women and International Development Annual, and has published extensively on gender and agriculture.

RICHARD MKANDAWIRE is Senior Lecturer in Rural Development at the Bunda College of Agriculture, University of Malawi. He is the author of several articles on agricultural systems in Malawi, and has just completed a major study of the agricultural estate sector in Malawi.

PETER MORTON-WILLIAMS is Emeritus Professor of the University of Ulster. For his early fieldwork, in 1950–58, he specialised in Yoruba studies; he subsequently taught at the Universities of Ghana, London, Cape Coast and Ulster, and is now Honorary Research Fellow in Anthropology at University College London.

DESSALEGN RAHMATO is a Senior Research Fellow at the Institute of Development Research, Addis Ababa University. His previous works include Agrarian Reform in Ethiopia (1984) and Famine and Survival Strategies (1991). He is working on peasant perceptions of environmental change.

LEONARDO VILLALÓN is Assistant Professor of Political Science and Courtesy Professor of African Studies at the University of Kansas. Following fieldwork in 1988–89, he completed his dissertation for the University of Texas at Austin. He is working on a comparative study of five francophone Sahelian countries.

BRAD WEISS is completing his doctoral thesis in anthropology at the University of Chicago.
