"CONNECTIONS: A BAROQUE FESTIVAL YEAR," is the title of a series of events to be held throughout 1982–83 under the sponsorship of Calvin College, Grand Rapids, Michigan. "THE DRAWINGS OF ANDREA PALLADIO" is the title of an exhibition being held at the Fogg Museum, Harvard University, January 15–February 28, 1982. The exhibition was organized by the International Exhibitions Foundation in honor of the IV centenary of Palladio's death. It is supported by grants from Fiat S.p.A. Turin, Italy, the National Endowment for the Arts, and an indemnity from the Federal Council on the Arts and Humanities. Works have been chosen from both public and private collections in England, Italy, and the United States by Douglas Lewis (National Gallery of Art, Washington, D.C.), a member of the advisory Council of the Palladian Center, Vicenza.

THE ACCADEMIA PETRARCA OF AREZZO plans to resume annual publication in 1982 of its journal *Studi Petrarcheschi*, the last issue of which was Vol. IX (1978). THE NEWBERRY LIBRARY will temporarily suspend its services to readers, as well as its reference services by telephone and mail, photoduplication services, and interlibrary loans February 1-April 30, 1982. During the three months that the library is closed, the collections will be moved from the present building to the new bookstack building now being completed. All library materials on reserve will be recalled prior to moving. Although most services will resume in May 1982, it is suggested readers write or telephone before visiting the library.

THE CENTRE FOR REFORMATION AND RENAISSANCE STUDIES at Victoria University (in the University of Toronto) offers each year a limited
