

WOLFHART PANNENBERG

Allan D. Galloway

This book is intended as an introduction for those who do not already know Pannenberg's theology and to discuss some of the problems which it presents for those who do. Whilst Pannenberg's theology of history has already been widely discussed, this is the first work to treat his theology as a whole—his doctrine of man, of history, of God and the Trinity, of Christology and resurrection, of church and eschatology—showing how it all hangs together. It presents Pannenberg's work sympathetically, but not uncritically. Criticisms which others have made are discussed and some new ones offered. The exposition is creative, offering fresh interpretations and occasionally, venturing to suggest possible improvements in Pannenberg's presentation of his argument. It is thus an original contribution as well as an interpretation.

David Friedrich Strauss and his Theology

HORTON HARRIS

A study of David Friedrich Strauss, certainly the most notorious and arguably the most important theological figure of the nineteenth century. His *Life of Jesus* (1835), repudiating the historicity of the Gospels, split the century into two theological eras and set in motion the 'Quest for the historical Jesus' and the ensuing investigation into the authenticity of the N.T. writings.

Dr Harris presents his study as a theological biography, quoting freely from the publications and private correspondence of Strauss and his friends. This is the only study in English of this controversial figure, and will be of interest to a wide range of theologians, historians and biblical scholars.

The Problem of Metaphysics

Metaphysics is usually taken to be that part of analytical philosophy which offers an account of the most basic and pervasive concepts we use such as existence, substance, change and quality. This book examines the reasoning involved in the debate between traditional Christian theism and its secular critics. It provides a convincing argument that theism can neither be proved nor shown to be logically incoherent; and that the case for it, as for any secular alternative, has to be a cumulative one, relying on a set of converging arguments which cannot be entirely formalised. Such a pattern of argument, it is contended, is found also in critical exegesis and history, disciplines in which evidence is limited and the area of disagreement comparatively restricted.
