Steinberg This article compares trade-environment rules and their negotiation and implementation in the context of the European Union, the North American Free Trade Agreement and the World Trade Organization. As economic integration deepens in each organization, the development of trade-environment rules becomes of increasing interest to richer, greener countries. Professor Steinberg concludes that the interests and power of those countries explain why environment-friendly rules are developing more quickly and thoroughly in the two regional organizations than in the multilateral organization.

**Continuing Search for Reconciliation** Thomas J. Schoenbaum The November 1995 report issued by the World Trade Organization's Committee on Trade and Environment is only a timid first step toward reconciling trade and environmental values. This article advocates the establishment of an ongoing process to deal with trade and environment issues and offers specific suggestions for resolving these issues largely within the framework of existing WTO agreements and jurisprudence. Nevertheless, amendments and clarifications of WTO agreements will be required, and a role for unilateral action will remain.
