GEOFF ELEY is Karl Pohrt Distinguished University Professor of Contemporary History at the University of Michigan, Ann Arbor (Department of History, 1029 Tisch Hall, 435 S. State St., Ann Arbor, MI 48109; email: ghe@umich.edu). His most recent works include *Forging Democracy: The History of the Left in Europe, 1850–2000* (2002); *A Crooked Line: From Cultural History to the History of Society* (2005); (with Keith Nield) *The Future of Class in History: What's Left of the Social?* (2007); and *Nazism as Fascism: Violence, Ideology, and the Ground of Consent in Germany, 1930–1945* (2013). He is currently writing a general history of Europe in the twentieth century.

JOSHUA HAGEN is professor of geography at Marshall University (One John Marshall Drive, Huntington, WV 25755; email: hagenj@marshall.edu). He has published widely on issues related to urban planning, historic preservation, and nationalism, including articles in the *Journal of Historical Geography*, *Environment and Planning D: Society and Space*, *Cultural Geographies*, *Journal of Urban History*, *Nationalities Papers*, and *Annals of the Association of American Geographers*. He has also coauthored works on geopolitics and border studies, including *Borders: A Very Short Introduction* (2012) and *Borderlines and Borderlands: Political Oddities at the Edge of the Nation-State* (2010). He is currently finishing a book examining the range of building programs implemented or envisioned by the Nazi regime.

SCOTT H. KRAUSE is a Ph.D. candidate in modern European history at the University of North Carolina at Chapel Hill (Department of History, Hamilton Hall, CB#3195, UNC-CH, Chapel Hill, NC 27599; email: skrause@email.unc.edu). His dissertation, “Outpost of Freedom: A German–American Network’s Campaign to Bring Cold War Democracy to West Berlin, 1940–1963,” examines how a network of German leftists and American liberals helped West Berlin emerge in the early Cold War as a heroic bastion of liberal democracy. Krause’s research has been supported by fellowships from the DAAD, the German Historical Institute, the Robert Bosch Foundation, and the Bielefeld Graduate School in History and Sociology. His publications include (with Stefanie Eisenhuth) “Inventing the ‘Outpost of Freedom’: Transatlantic Narratives and the Historical Actors Crafting West Berlin’s Postwar Political Culture,” which appeared in the journal *Zeithistorische Forschungen/Studies in Contemporary History* in 2014.

MICHELLE MOUTON is associate professor of history at the University of Wisconsin Oshkosh (History Department, 800 Algoma Blvd, Oshkosh, WI 54901; email: mouton@uwosh.edu) and author of *From Nurturing the Nation to Purifying the Volk: Weimar and Nazi Family Policy 1918–1945* (2007). Her work on Weimar and Nazi family policy has appeared in numerous journals, including *Central European History*, *History Workshop Journal*, and *Journal of Social History*. Currently she is working on a book about German children during the transition from World War II to the Cold War in East and West Germany.

KIM CHRISTIAN PRIEMEL is a Dilthey Fellow and assistant professor of modern history at Humboldt University Berlin (Institut für Geschichtswissenschaften, Unter den Linden 6, 10099 Berlin; email: priemelk@geschichte.hu-berlin.de). He studied modern history, law, and English literature at the University of Freiburg in Germany and at the University of St. Andrews in Scotland. He earned his Ph.D. from the University of Freiburg in 2007 and is currently working on a new history of the Nuremberg war crimes trials.

The journal solicits manuscripts using all approaches to history and dealing with all historical periods. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.

The editors prefer that manuscripts be submitted in electronic form as email attachments sent to the journal's address, preferably in Microsoft Word 2003 or later or WordPerfect 12.0 or later; Adobe Acrobat pdf files will also be reviewed. Manuscripts submitted in printed form must be accompanied by a compact disk or diskette with the article in Word, WordPerfect, or pdf. The entire text of all manuscripts, including footnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Footnotes must be numbered consecutively and should be placed in a separate section at the end of the text.
