Suas áreas de interesse são a cultura política, participação política e opinião pública.

CRISTINA GARCÍA-MORENO es profesora del Departamento de Antropología, Filosofía y Trabajo Social de la Universitat Rovira i Virgili (URV) de Tarragona, España, y doctora en antropología por la URV. Entre sus principales líneas de investigación destacan las migraciones transnacionales, la migración cubana, migración y género (sistemas, relaciones e ideología de género), migraciones por amor y matrimonios mixtos (binacionales, relaciones sentimentales transnacionales). EVE KALYVA is an art critic working on the relation between art and politics, conceptual and contemporary art practices, multimodality and social semiotics. She has held appointments as lecturer in Europe and Latin America and has collaborated with art institutions as curator, critic, and artist in residence. Her publications span art history and theory, philosophy, social semiotics, Latin American studies, and visual culture.
