## NOTES ON THE CONTRIBUTORS

**STEPHEN P. MUMME,** Associate Professor of Political Science at Colorado State University, coauthored Statecraft, Domestic Politics, and Foreign Policy Making: The El Chamizal Dispute. His current research focuses on environmental policy development in Latin America and the Third World.
