China's Vernacular Architecture House Form and Culture Ronald G. Knapp

This book documents one of China's most significant vernacular architectural traditions and broadens our understanding of the cross-cultural meaning of the common house. Illustrated with more than three hundred original photographs and drawings collected during fieldwork in scores of rural villages, this volume examines the distinctive characteristics of the common house in Zhejiang province.

Here, as elsewhere in the world, village and town settlements reflect the ways in which living and productive spaces are formed and used. The author clarifies many facets of the common house, emphasizing the nature of settlement clusters in which dwellings are found, the organization of space and structure which gives houses form, as well as the cultural context that enriches Zhejiang dwellings. Although highlighting ordinary houses, Knapp presents the links between vernacular traditions and the shared cultural aesthetic values of China's literati. The dwellings of Zhejiang not only communicate folk beliefs, they also express the conjoined cosmological and technical practices of China's imperial architectural tradition seen in palaces and temples.

JUNE FOUR A Chronicle of the Chinese Democratic Uprising by the photographers and reporters of the *Ming Pao News*

Triggered by the death of Hu Yaobang, the former general secretary of the Chinese Communist party, a pro-democracy movement swept mainland China, building up to mammoth demonstrations that were without precedent in the history of the People's Republic. The whole world was impressed by the peacefulness of the mass movement and by the restraint of the authorities for seven weeks; then troops opened fire on defenseless students and other citizens. The government cleared the Square in a ruthless assualt, with disastrous results for the country and its people.
