# INSTRUCTIONS TO AUTHORS

Manuscripts in the areas of finance and quantitative analysis should be sent to the editor. Two copies should be enclosed and the authors' names should not appear on the manuscript to preserve anonymity. The manuscripts will then be forwarded to the appropriate associate editors. Manuscripts should be typed on  $8-1/2 \times 11$  paper and should be doublespaced. Mathematical notation should be kept as simple as possible. Where at all possible use common typewriter characters such as primes, slashes, asterisks, etc.

Footnotes should be numbered consecutively and typed in a separate list at the end of the paper. Do not use footnotes on mathematical symbols. Reference material should be listed alphabetically on a separate sheet at the end of the manuscript.
