

THE ISLAMIC TEXTS SOCIETY

The Islamic Texts Society was founded in 1981 as a non-profit scholarly society with the objective of promoting a deeper understanding of Islam through the publication of English translations of works of traditional importance to the Islamic faith and culture.

Among its recent successes have been Muhammad, His Life Based on the Earliest Sources by Martin Lings, Islam and the Destiny of Man by Gai Eaton, a two volume edition of E W Lane's Arabic English Lexicon and the video presentation entitled Islam: A Pictorial Essay in Four Parts. The Society has now established three imprints. Under the Golden Palm imprint the society is preparing a series of titles on the Islamic Arts including a revised and expanded edition of Martin Lings' Quranic Art of Calligraphy and Illumination, and an English version of Titus Burckhardt's Fez, City of Islam using the author's original photographs. This series will begin publication, in association with the publishers Thames and Hudson, in 1988.

In the Islamic Texts Society monograph series early 1988 will see the publication of new editions of two important works, *Science and Civilisation in Islam* by Seyyed Hossein Nasr, and *ShāfiT's Risāla* translated by Majid Khadduri. We are also preparing for publication in 1988 a new translation by Timothy Winter of Ghazāli's *The Book of the Remembrance of Death and the Afterlife* and a revised edition of Dr. Kojiro Nakamura's translation of Ghazāli's *On Prayer*. Also under active preparation is an edition of Ibn Qayyim al-Jauziyyah's *Medicine of the Prophet*. Several important reprints are also being considered.

In addition the Quinta Essentia imprint has been established to publish other works of Traditional value. Its first two titles are The Eleventh Hour: The Spiritual Crisis of the Modern World in the Light of Tradition and Prophecy by Martin Lings (£10.50), and Mirror of the Intellect: Essays on Traditional Science and Sacred Art by Titus Burckhardt (£20.50).

This Society is interested in learning from scholars who are working in the relevant fields and who have projects either in hand or who are planning such projects as might be of use to the Society's programme.

The Society has also opened The Green Street Book Shop at its premises in Cambridge. As well as holding a comprehensive stock of Islamic books the shop has a wide ranging stock of both new and secondhand books in the following fields:

Arabica, Religions, Egyptology, Metaphysics, Classical, Mediaeval and Renaissance Studies, Symbolism, History of Science, Byzantium, Ancient Civilisations, Mysticism, and Traditional Studies.

We issue specialist catalogues, the most recent of which *Islam and the Muslim World* (part one of a two part catalogue listing new and antiquarian titles) is now available.
