OBITUARIES should be submitted to the editor, *The SAA Archaeological Record*, for publication (see *SAA Bulletin* March/April 1996, p. 7, for further details).

Authors are required to submit manuscripts electronically through Editorial Manager® (<http://www.editorialmanager/aaq>).
