

more in length. The Association will follow the same procedure described above for complete articles. The fee to the APSA for a table, figure, or selection is \$50 and the author's fee, if requested, will be \$50 to \$100. The author will also have the option to request the right to review any selection in which deletions or editorial changes have been made.

The Association's reprint permissions policy reflects the advice of its Committee on Publications and principles specified in its *A Guide to Professional Ethics in Political Science*.

## The American Political Science Association Policy and Procedures for Permission to Copy Articles for Class Assignments, April 1992

The Association wishes to facilitate the classroom use of articles in its journals, *The American Political Science Review* and *PS: Political Science & Politics*. The policy and procedures to accomplish this objective consider the needs of faculty and students who use the articles and protect the rights of the authors and the Association which holds the copyrights.

To assure access to articles, there is no fee and no prior clearance requirement for the first 10 copies of an article. In other words, up to, but no more than 10 copies can be made of a single article, either to be distributed directly to individual students in a small class or to be placed on reserve in a library.

The Association's permission to copy and distribute any article(s) must be requested if more than 10 copies will be produced. This applies to the distribution of any article(s) separately, as well as to any article(s) that are included in a special reader or text prepared for a faculty member by a copying service.

The request for permission to copy one or more articles must be accompanied by:

- a full citation of the article(s);
- the title of the course in which it is assigned;
- the name of the course's instructor

- who is assigning the article; and
- the number of copies that are to be made.

The fee for more than 10 copies of an article is 75c for each additional copy. Prepayment of these fees is required unless specific prior arrangements have been made.

The Association will expedite the permissions process to assure that materials can be distributed when students will need them.

The Association's policy on copying articles for class use has been prepared by its Committee on Publications and reflects principles specified in the APSA's *A Guide to Professional Ethics in Political Science*.

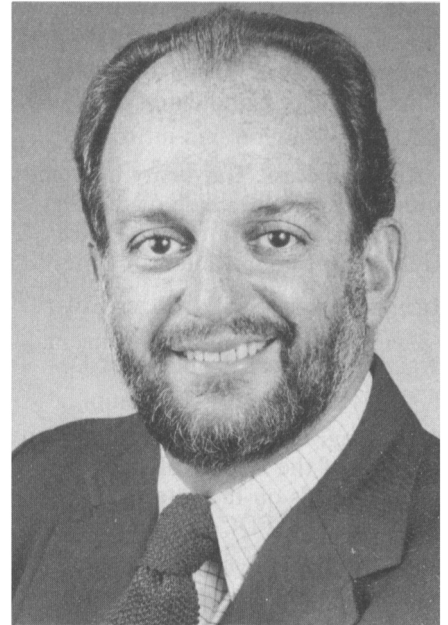

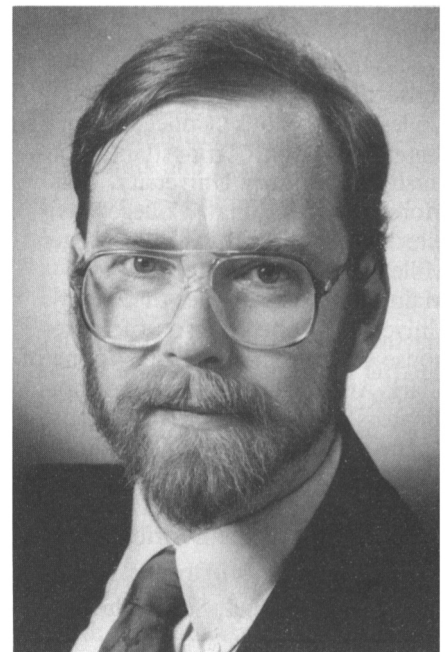

### Federal Executives Win Congressional Fellowships

The Association also selected 22 federal executives as Congressional Fellows for the 1992-93 program and expects to name two more before September.

The recipients, advanced career civil servants, are scheduled to participate in the program from early November 1992 through mid-August 1993.

Of the 22 federal executives, eight have been named Foreign Affairs Fellows and will take part in a special two-month seminar on Congress and Foreign Policy. The course is taught by Professor Frederick Holborn at the Paul H. Nitze School of Advanced International Studies (The Johns Hopkins University) prior to the beginning of the general orientation. Foreign Affairs Fellows are federal executives who serve in foreign policy positions in their agencies.

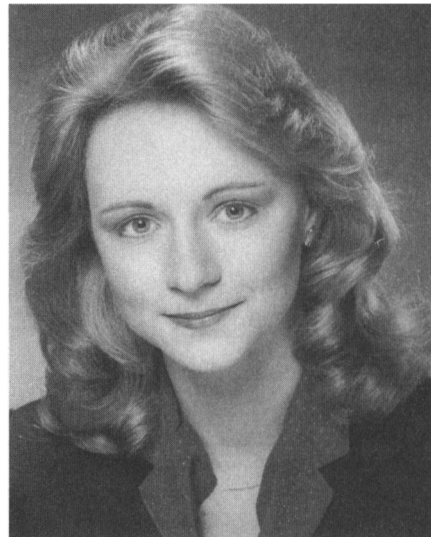

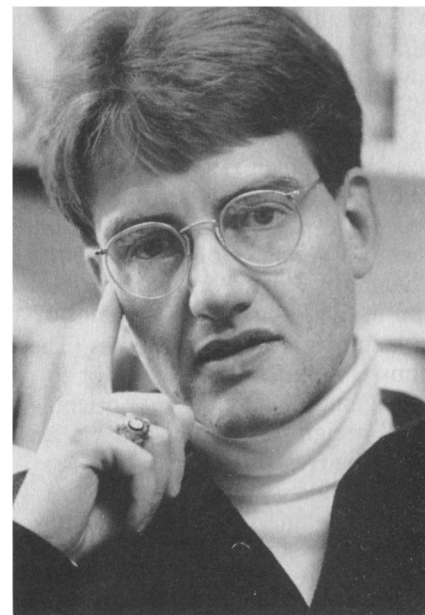

She received her Bachelor of Arts degree in sociology from Kalamazoo College in 1988 and has studied at the International Institute in Madrid,

The Poynter Fellowship is awarded to a talented and promising print journalist. Funding is provided by the Poynter Fund, the charitable foundation of the Times Publishing Company whose publications include *Congressional Quarterly Weekly Report* and the associated publications of Congressional Quarterly, Inc., as well as the *St. Petersburg Times*. Andrew Barnes is president of the Poynter Fund and chairman and chief executive officer of the Times Publishing Company.

*Craig A. Rimmerman: William A. Steiger Congressional Fellow*

Craig Alan Rimmerman, associate professor and chair, department of political science, Hobart and William Smith Colleges, has been named the fourth William A. Steiger Congressional Fellow. Dr. Rimmerman has served on the faculty of Hobart and William Smith Colleges since August 1986 and previously had taught for two years at the College of Charleston. He earned his Ph.D. in political science from Ohio State University in 1984.

The William A. Steiger Congressional Fellowship honors the memory of the late William A. Steiger, a Republican who represented the Sixth District of Wisconsin from 1966 until his untimely death in 1978. During his service in Congress, he was dedi-

cated to the Congressional Fellowship Program and was an active member of its Advisory Committee. The Fellowship is awarded annually to a political scientist or journalist who best exemplifies Representative Steiger's values and interests.

Fundraising for the William A. Steiger Congressional Fellowship is under the direction of the William A. Steiger Congressional Fellowship Development Committee, which seeks to raise an endowment to support the Fellowship in perpetuity.

All four Fellowships are awarded through rigorous national competition, and winners participate in APSA's Congressional Fellowship Program along with other political scientists, journalists, federal executives, health policy professionals, international fellows and others.

**Professor Dr. Ernst Otto Czempiel Steps Down from Selection Committee for German Congressional Fellows**

Prof. Dr. E. O. Czempiel, Johann Wolfgang Goethe-Universitat, Frankfurt, recently resigned from the committee that selects German candidates for the Congressional Fellowship Program. Dr. Czempiel had served on the committee since its inception in 1982. He will be replaced by Pro-

fessor Peter Losche of Gottingen University.

The German component of the Congressional Fellowship Program was initiated in 1981 by Professor Dr. Helga Haftendorn, Free University of Berlin, with the cooperation of Dr. Stephen F. Szabo, then with the Foreign Service Institute, U.S. Department of State, and principals of The German Marshall Fund of the United States, including Jackson K. Janes, the Fund's European Representative at the time.

The first German Fellows, Eberhard Barg of the Information Office

for German-American Exchange in Berlin, and Dr. Bernd Kubbig of the Peace Research Institute Frankfurt, entered the Congressional Fellowship Program in November 1982. The German selection committee was composed of Professor Dr. Helga Haftendorn, chair, Professor Dr. Ernst Otto Czempel and Professor Winfried Steffani of the University of Hamburg. Among others who have served on the committee since then are Professor Dr. Graf Vizthum, Eberhard-Karls Universitat Tubingen, and Professor Dr. Kurt Shell, Johann Wolfgang Goethe-

Universitate, Frankfurt, who has been supportive of the program from the beginning. In 1987 Professor Shell became chairman of the selection committee.

To date, twenty Germans have been APSA Congressional Fellows, and two more have been selected to participate in the 1992-93 program. The German Marshall Fund of the United States has provided the major support for the German component since its inception, along with generous contributions for several years from The John J. McCloy Fund of the American Council on Germany.
