EURIPIDES: HYPSIPYLE

Edited by G. W. BOND. (Oxford Classical and Philosophical Monographs). This is the first annotated edition since that of G. Italie (Berlin 1923). The present editor proposes considerable alteration to the traditional order of the papyrus fragments and a tentative reconstruction of part of the papyrus roll. The edition contains a text and commentary with an Introduction dealing with the principal problems of the play. (\$7.75)

DOCUMENTS OF THE CHRISTIAN CHURCH

Edited by HENRY BETTENSON. This new edition is enlarged to include additional documents on the Independents (1685), Catholic Social Policy (1891, 1931, and 1961), the dogma of the Assumption (1950), Anglican Orders (1897), the Church of Scotland (1921), the Church of South India (1947), and the World Council of Churches (1948 and 1961).
