The C.J.P. is bringing its volume into line with the calendar year. This will be achieved by publishing Volume V in the second half of 1975. Volume V, nos. 1-4 will be dated September, October, November and December 1975. Nos. 1 & 2 will appear in September 1975 and nos. 3 &4 in December 1975. The March 1976 issue will be Volume VI, no. 1; we will thereafter resume our normal publishing schedule.

Since its inception in September 1971, the C.J.P. has managed, by increasing circulation and generous outside support, to maintain the same level of subscription charges while expanding to a journal of 750-800 pages per volume. However, the steadily increasing costs of journal publication have finally caught up with us. We have reluctantly come to the conclusion that we must increase subscription prices for Volume VI. 
