LIBRARIES AND ARCHIVES

Aid to University Libraries in Latin America—Programs for the improvement of university libraries in Latin America are continuing with support from AID, the Ford and Rockefeller Foundations, and with the technical assistance of several U.S. librarians. Ford Foundation grants provide assistance and advisory services to the University of Chile and Catholic University in Santiago. The Rockefeller Foundation supports a library director from the United States for the Universidad del Valle in Cali, Colombia. Two librarians from the University of Minnesota staff are advising the University of Concepción, Chile, on its Library services. An AID contract with St. Louis University supports a U.S. librarian serving for a third year in the organization of library services for the Catholic University in Quito.

Bibliographical Activities of INIA—Projects in progress as the Instituto Nacional de Investigaciones Agrícolas in Mexico include the following: 1) *Catálogo colectivo de publicaciones periódicas existentes en bibliotecas de la República Mexicana*. Pablo Velásquez and Ramón Nadurille of Biblioteca INIA are preparing this compilation for publication in 1967. Relying on information solicited on 35,000 postcards from some 120 libraries, the bibliography will list complete volumes and the numbers held of the incomplete ones for each of the titles registered in the cooperating libraries. 2) *Las obras de consulta en español; una lista preliminar* will be developed from some 5,000 file cards obtained primarily from secondary sources. It is to be published in 1967. 3) *Bibliografía agrícola y agraria de México, 1945–1966*. This is compiled as are the two above, by Velásquez and Nadurille. These two authors will also prepare the Directorio Agronómico Nacional, a bio-bibliographical directory of persons conducting agricultural research in Mexico. Biblioteca y Archivo del Congreso Nacional—Under the direction of Lourdes Esther García, efforts are being made to rehabilitate by lamination processes the priceless documents possessed by the Biblioteca y Archivo del Congreso Nacional in Caracas and to organize them for research purposes.

Conference on Latin American History Bibliographical Programs—The Serial Division of the Library of Congress, under whose direction an inventory of 19th and 20th century Latin American newspapers in U.S. depositories is being developed, has received reports of holdings from 74 research libraries, including the catalogue of the American Antiquarian Society which contains holdings for about 1,800 titles. When the basic inventory is completed and the holdings are recorded from the 84 libraries solicited, the CLAH Committee, working with representatives from institutions with a major interest in Latin American studies, will indicate those missing newspapers most desirable for filming. The program's long-term goal is to have for each Latin American country a set of the important newspaper files spanning the years from about 1825–1938.

The first work in the CLAH Publications Series will be an anthology edited by Howard Cline, *Latin American History: Essays on its Study and Teaching in the United States, 1898–1965*. Also scheduled for publication in this series are the translations of Soviet materials edited by J. Gregory Oswald.

Hampshire Inter-Library Center List of Latin American Periodicals—In November 1965 HILC issued a union list of serials relating to Latin America currently received at Amherst, Mt. Holyoke, Smith, the University of Massachusetts, and at HILC itself, which is a research library owned by the other four. The list provides information on holdings at each of the libraries as well as titles of currently received periodicals. Director of HILC is Pauline Collins, a Latin American specialist in literature and a professional librarian.

Hispanic Foundation Projects in Progress—The preparation and compilation of the Cumulative Index to Numbers 1–25 of the *Handbook of Latin American Studies* is under the direction of Mr. and Mrs. Francisco Cardona. The University of Florida libraries, under contract with the Library of Congress, is responsible for the project.

The 11-volume *Handbook of Middle American Indians*, under the general editorship of Robert Wauchope, is designed as the Middle American counterpart of the *Handbook of South American Indians*, covering the archaeology, ethnohistory, ethnology, natural history, and physical and social anthropology of the cultural area between northern Mexico and Panama. The University of Texas has published volume 1, edited by Robert C. West, and volumes 2 and 3, edited by Gordon R. Willey. Volumes 9 and 10, under the

editorship of the director of the Hispanic Foundation will form a "Guide to Ethnohistorical Sources," with essays and special bibliographies. Volume 9 will cover "European Traditions," and volume 10 "Native Traditions." Preparation of volume 9 is scheduled to terminate about June 1967, and volume 10 about June 1968.

An Hispanic Foundation project still in its early stages of development is *Latin America: A Bibliography of U.S. Official Publications, 1945-1965*. A major source for the bibliography, which will treat primarily with publications in the social sciences and humanities, is the *Monthly Catalog* of the Government Printing Office. Later, if feasible, an attempt will be made to provide selected coverage of other U.S. official publications not published by the GPO.

Latin American Book Programs, Inc.—LABP is a new non-profit organization for the dissemination of Latin American culture and the promotion of hemispheric understanding through books. It proposes to publish a series of inexpensive paperbacks, in English translations, of the best novels, essays and biographies, etc. of well known Latin American authors. The organization also aims to promote a series of books on Latin American history and geography geared for the 8th to 12th grades; a textbook series on Latin American anthropology-sociology and contemporary history at the university level; a line of books on Latin American marketing, economy, advertising for U.S. businessmen; and books on the arts, archaeology, folklore and music of Latin America. University of Massachusetts Latin American Acquisitions Program—Since July 1965 the University of Massachusetts library has been on the All Books Current Plan (ABC) through which all books of university interest currently published in various world areas are ordered automatically. For Latin America the ABC Plan was applied initially to seven South American countries and has recently been extended to other areas.

New York State Education Department Bibliographical Project—This three-year cooperative project involving college librarians and scholars in foreign area studies is designed to strengthen undergraduate library resources useful in teaching about those areas of the world traditionally neglected in American colleges and universities. It involves a survey of bibliographies and reference works on Asia, Africa, Latin America, and Russia and East Europe, inter alia. The Foreign Area Materials Center, New York State Education Department, supported by a contract with the U.S. Office of Education, is carrying out the project under the general direction of Ward Morehouse. The Foreign Area Materials Center is interested in knowing of any bibliographies

PAU Receives Grant to Compile List for University Libraries—The Council on Library Resources, Inc., of Washington, D.C., has made a grant of \$1,200 to the PAU. The funds will be used to assist in convening a meeting in Mexico City to plan the details and determine the cost of a project to compile a selection list for Latin American university libraries. A single list of books and periodicals especially compiled for Latin American universities would enable librarians and faculty members to choose titles with greater understanding, improve the quality of the collections, create new university general collections, and provide a basis for improved research and teaching programs. University of Pittsburgh Builds Latin American Collection—The most recent acquisition is a collection of approximately 21,000 items dealing with Mexican history and Latin American literature. Another large collection was acquired from Ecuador, and funds have been earmarked for additional purchases. The total number of books in Spanish is unknown, but it exceeds 50,000 in recent purchases alone.

State University of Utrecht Latin American Acquisitions—The Spanish, Hispanic-American and Luso-Brazilian collections of the Institute of Hispanic, Portuguese and Iberoamerican Studies increased considerably during 1965. Among the acquisitions were 23 volumes of the *Biblioteca de Mayo, Colección de Obras y Documentos para la Historia Argentina*, Buenos Aires 1960–1966, donated by J. Aníbal Dávila, president of the Argentine Senate.

GRANTS, AWARDS, PRIZES

Agricultural Development Council

The ADC is continuing in 1966–67 a program of grants to facilitate research in international agricultural development by professors of American universities. Proposed studies should relate to the economic and human problems of agricultural development in the developing nations. Applications are entertained from economists, sociologists, anthropologists and other social scientists. Preference is given to proposals that promise to increase understanding of the process of agricultural development. Most studies involve field work in Asia, Africa, or Latin America. Grants average about \$6,000 in a range of \$500 to \$15,000. Applications for grants up to \$2,500 may be submitted to the Council at any time. For grants of more than \$2,500, applications are considered three times each academic year. Applications received by October 15, 1966, will be considered for award by November 15, 1966. Concurso Latinoamericano del Cuatricentenario de Caracas

In honor of the fourth centenary of the Founding of Caracas, the national commission for the Cuatricentenario has convoked a Latin American competition on the following topics: 1) Venezuela and the Economic Integration of Latin America; 2) Petroleum in Latin America; 3) Stability and the Economic Development of Latin America; and 4) Present Economic Problems in Latin America. Persons eligible to compete must be nationals or residents of Latin America, and they must present unpublished works written in Spanish or Portuguese. The length should be between 250 and 500 double-spaced, typed pages. Three copies of the work should be submitted, accompanied by a summary and the conclusions in 20 or 25 pages. April 30, 1967, is the deadline for submissions. The prize for each work is 22.500,00 Bolivares (\$5,000). In
