## Mexican Law and Legal Literature

The Library of Congress has recently published A Revised Guide to the Law and Legal Literature of Mexico, superseding a 1945 work originally published as one of a series of 10 guides to Latin American law. Helen L. Clagett and David M. Valderrama, Hispanic Law Division of the Law Library, have co-authored the new 463-page book. Lewis C. Coffin, former Law Librarian, instituted and authorized the revision of the guides, starting with the one for Mexico. Work is now in progress on the revision by David M. Valderrama of the guide for Peru.

The new Mexican guide combines legislative history and commentaries on the codified and statutory fields of law with exhaustive bibliographical footnotes to the
