His books and articles on German history focus on the relations between religious and ethnic groups: Protestants and Catholics, Christians and Jews, Germans and their neighbors. He is the author of German Nationalism and Religious Conflict, 1870-1914 (Princeton, NJ, 1995), and a number of edited collections, including Protestants, Catholics, and Jews in Germany, 1800-1914 (Oxford, 2001); The Holocaust and other Genocides: History, Representation, Ethics (Nashville, TN, 2002); and, with Werner Bergmann and Christhard Hoffmann, Exclusionary Violence: Antisemitic Riots in Modern German History (Ann Arbor, MI, 2002). His book, The Butcher's Tale: Murder and Anti-Semitism in a German Town (New York, 2002), received the Fraenkel Prize in Contemporary History and was an L.A. Times Non-Fiction Book of the Year. Smith has recently completed The Continuities of German History: Nation, Religion, and Race across the Long Nineteenth Century (Cambridge University Press, 2008), and he is the editor of the Oxford Handbook of Modern German History, scheduled to appear in 2010. He is also working on The Discovery of Germany: A Cultural History, 1500-2000, which will appear with W. W. Norton and C. H. Beck in German.

Because space is limited, articles which have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.

The editors prefer that manuscripts be submitted in electronic form as e-mail attachments sent to the journal's address, preferably in Microsoft Word 2003 or later or WordPerfect 12.0 or later; Adobe Acrobat pdf files will also be reviewed. Manuscripts submitted in printed form must be accompanied by a compact disk or diskette with the article in Word, WordPerfect, or pdf. The entire text of all manuscripts, including footnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Footnotes must be numbered consecutively and should be placed in a separate section at the end of the text.
