


ORGANIZED LABOUR AND POLITICS IN MEXICO

Changes, Continuities and Contradictions

By Graciela Bensusán and Kevin J. Middlebrook

This book examines the changes, continuities and contradictions characterizing labour politics in Mexico since the 1980s. As a consequence of market-liberalizing reforms and historic shifts in government policy toward organized labour, the labour movement has declined substantially in size, bargaining strength and political influence. Electoral democratization has expanded individual workers' choices at the ballot box and increased political pluralism in the labour movement. Some unions have also bolstered their power resources by forging transnational alliances with counterparts in Canada and the United States.



On the whole, however, democratization has had remarkably little impact on the state-labour relations regime institutionalized following the Mexican Revolution of 1910-20. This legal regime both underpins the position of unrepresentative union leaders and grants government officials highly discretionary control over the formation of unions, the election of union leaders and unions' actions. The combination of weakened labour organizations, unaccountable union leaders and strong government controls fundamentally constrains workers' capacity to defend their interests. This state of affairs — and especially the failure to enact progressive labour law reform since democratic regime change in 2000 — limits democracy and imposes heavy costs on both unionized workers and Mexican society as a whole.

By engaging debates concerning organized labour's role in democratization, and by demonstrating the essential compatibility between market-focused economic policies and state-labour practices rooted in Mexico's authoritarian past, this book contributes to a broader assessment of organized labour's role in contemporary Latin America.

NOTES FOR CONTRIBUTORS Editorial Policy

The Journal of Latin American Studies is published four times a year, in February, May, August and November. Its editorial offices are located at the Institute for the Study of the Americas, University of London. The editorial board comprises area studies specialists based in the United Kingdom from all the principal social science disciplines, including history.

The *Journal* aims to publish recent research in the field of Latin American studies in economics, geography, politics, international relations, sociology, social anthropology and history. Articles on literature and the arts are not normally included, but the editors are pleased to consider contributions in the field of intellectual and cultural history. Articles with an interdisciplinary approach are particularly welcome.

Manuscript Submission

Articles submitted to the *Journal* should be original contributions. They should not be under consideration by another journal, nor have been published or be awaiting publication elsewhere. Translations of articles that have already been published will not be accepted. If an author is publishing a closely related article elsewhere, this fact should be stated in a cover note to the editors. Authors of articles published in the *Journal* assign copyright to Cambridge University Press (with certain rights reserved) and will receive a copyright assignment form for signature on acceptance of their paper.

Articles should be between 10,000 and 12,000 words, including footnotes, tables etc. The *Journal* is published in English, but articles may also be submitted in Spanish or Portuguese for peer review; if accepted for publication, the responsibility for translating articles rests with the author. The *Journal*'s preference is that manuscripts should be submitted electronically as a Word document, with double spacing throughout and margins of at least one inch all round. All pages must be numbered consecutively. In order to ensure the anonymity of the reviewing process, care should be taken to ensure that any references which might identify the author are removed from the text. The title page should be separate from the main body of the text and include the author's name, academic post and institutional affiliation, the title of the article, and brief acknowledgements. An abstract of no more than 100 words, together with a list of keywords, should appear at the beginning of the article.

The *Journal* publishes commissioned book reviews in each issue. Not all books received can be reviewed, and editorial policy gives preference to reviews of books regarded as being of major importance for the disciplines covered by the *Journal*. Unsolicited reviews cannot be considered.

Contributors are responsible for obtaining permission to reproduce any material for which they do not own copyright, to be used in both print and electronic media, and for ensuring that the appropriate acknowledgements are included in their manuscript.
