



DEMOCRACY IN URBAN AMERICA: READINGS ON GOVERNMENT AND POLITICS

Edited by OLIVER P. WILLIAMS, Fels Institute of Local and State Government, University of Pennsylvania and CHARLES PRESS, Michigan State University

The Editors of this book of readings have chosen articles which emphasize the problems pertaining to the role and function of local government in the democratic system. The assumption of this approach is that the "facts" about municipal government are those matters most easily learned and most easily forgotten.
