Organized Business in France By Henry W. Ehrmann

This is the first book to give a comprehensive description of a major French pressure group — the French employers' trade and association movement. Encompassing a dramatic period of French history from 1936 to the present, when organized business played a prominent role, Professor Ehrmann shows how the French employers' and trade association movement operates, how its policies are formed, and how its influence extends into the heart of French politics. He examines the chances for economic growth in mid-century France and analyzes the economic and social concepts of organized business as expressed in policy statements and in daily practice.
