

"His most important contribution to the field so far is the fresh two-volume set comprising one volume on the general history of East Asia and the other on the specific sphere of issues connected with the protohistorical relations between Korea and Japan. These books deserve special recognition not only for their insightful approach but also for their elegant design, with high-quality color pictures, maps, and extracts from primary sources integrated in the whole in a reader-friendly way.

The first of the two volumes is essentially a handbook of East Asian political and cultural history, chronologically arranged, and with a focus on Manchuria, historiographically the most neglected component of the tripolar complex. ... By the "tripolar approach" he means that East Asia should not be viewed from the traditional Sinocentric perspective (= the monopolar approach), nor in a framework involving China and "the unified nomads in the steppe" (= the bipolar approach), but, rather, in terms of a system of interaction between three actors of equal weight, but with different roles: China, Mongolia, and Manchuria. This is a holistic framework conceptualized by Gari Ledyard and Thomas Barfield (as well as by the present author), and as a model for understanding East Asian history it does not seem to have alternatives. Even so, much research is still being done on East Asia in the spirit of obsolete paradigms, which is why Hong's two books certainly serve a purpose as a healthy reminder of how things can also be seen. ... that make the reading of Hong's books so refreshing.

The second volume by Hong is more strictly focused on the protohistorical period, though it also has a modern political dimension. The principal objective of the book is to bring forth evidence in favor of the "Kudara-Yamato model," according to which the immediate origins of Yamato Japan were located in Paekche. The evidence itself is generally well known, extending from historical records to obvious cultural and archaeological parallels, but the problem is that the relevant facts have never been recognized by the Japanese national historiography. This forces Hong to criticize "the claustrophobic narrowness of the Japanese academic tradition" as a whole, a criticism that is certainly justified at least as far as the fields of archaeology and history are concerned. ... The role of Paekche in the early history of Japan is beyond any doubt. ... The political and military ties between Paekche and Yamato suggest an intimate partnership that is best explained by assuming an ethnic affinity. Hong must be right when he claims that "a member of the Paekche royal family carried out the conquest of the Yamato region in the late fourth century," thus laying the foundations of Japan as a political state. Much of Hong's book is devoted to the summarizing of the archaeological, historical, folkloric, and even onomastic evidence in favor of this claim. ... Hong's two books are, in general, much better argumented than anything presented by Japanese historians or even linguists during the recent decades."







## Memory, Violence Queues: Lu Xun Interprets China

This book takes a new look at the writer whose name is synonymous with the radical newness of modern Chinese literature. It identifies key moments in Lu Xun's creative development and places them in the context of the turbulent era in which China became a republic. The result is a fresh and nuanced interpretation of a range of works, from fiction and essays to classical poems. The analyses highlight the writer's engagement with epochal political events—the discarding of the queue style of hair, the failed monarchical restoration of Zhang Xun, the Five Martyrs incident of the leftist literary movement, and the parallel movement in art. A distinctive feature is the extensive use of visual materials and contemporary photographs. 




## Scattered Goddesses: Travels with the Yoginis

This is a book about the lost home, the new homes, and the journeys in between of nineteen sculptures that now reside in at least twelve separate museums across North America, Western Europe, and South India. After piecing together what these goddesses and their former companions might have meant when they were together in tenth-century South India, Kaimal traces them into the hands of private collectors and public museums as these objects became more thoroughly separated from each other with each transaction. In the process of export and purchase, and in the hostile as well as loving receptions these sculptures received within South Asia, she finds that collecting and scattering were the same activity experienced from different points of view.





ancient kingdom of Mustang (now part of Nepal) to establish a cultural center that will support and encourage the sustainability of his community's ancient and traditional heritage.




## THE LOVER AND THE BELOVED color, 70 min, 2011


A film about one man's journey across northern India and his search for enlightenment. This film





## REQUIREMENTS FOR MANUSCRIPT SUBMISSION

When preparing a manuscript, please note that JAS is committed to publishing articles based on in-depth, original research. Authors should also take care to address the interests of our broad, multidisciplinary readership by raising larger questions of interest that reach beyond their precise research specialties. Authors are encouraged to consult recent issues of JAS for guidance on style and formatting.

- Please submit all manuscripts and images to the Editor via the Editorial Manager website <a href="www.editorialmanager.com/jas/">www.editorialmanager.com/jas/</a>. Inquiries may be sent to <a href="jas@journalofasianstudies.org">jas@journalofasianstudies.org</a>. Electronic text should use MS Word-compatible software; include a PDF file if using non-standard characters. Low-resolution images and illustrations are acceptable for the review process; all images, tables and figures should include titles or captions. Please note that in the event of publication, the author is responsible for acquiring high-resolution images along with permission to publish them. If electronic submission is not possible, please contact the editorial office at the email address, phone number or fax number listed above.
- Article manuscripts, including notes and references, should range between 8,000 and 10,000 words, or approximately thirty-five pages in length, and must include a 150 word abstract at the beginning of the document.
- Authors' names must be left off of the manuscript, as JAS engages in double-blind reviews.
- Manuscripts must be double-spaced with 12-point type and 1 inch margins including extracts, notes, and references, and formatted for letter-size (8.5 × 11 in.) paper if possible.
- Notes should be as few as possible and appear at the end of the text.
- Use parenthetical in-text citation, and author-date formatting for references per *Chicago Manual of Style*, 15th edition (Chicago: University of Chicago Press, 2003), pp. 616–24.
- Please use the following Romanization: Chinese: Pinyin; Japanese: Hepburn; Korean: McCune-Reischauer.
- If you are unable to upload your manuscript to the Editorial Manager website, please contact the *JAS* office.
- Manuscripts submitted to JAS should not have been published elsewhere and should not be under review for publication elsewhere.
