CONTRIBUTORS TO THIS ISSUE

CHRISTOPHER CLAY is Reader in Economic History at the University of Bristol. He has published a study of the Restoration financier Sir Stephen Fox under the title *Public Finance and Private Wealth* (Oxford University Press, 1978), and several articles on land ownership and estate management in the seventeenth and eighteenth centuries. His current research interest is the eighteenth-century land market.

JOHN R. FISHER is Lecturer in Economic History at the University of Newcastle, N.S.W., Australia. He is the author of *Clare Sewell Read 1826-1905: A Farmers' Spokesman of the Late Nineteenth Century* (University of Hull Press, 1975), and numerous articles. At present he is working on English land tenure relations and aspects of animal disease control policies in the nineteenth century.

DEREK HIRST is Associate Professor of History at Washington University, St. Louis. His publications include *The Representative of the People?* (1975). He is completing *Authority and Conflict: England 1603-1658* and is working on a study of the rule of the Cromwellian Major-Generals.

BRUCE L. KINZER is Assistant Professor at McMaster University, Hamilton, Ontario. His previous publications include several articles on J.S. Mill. His forthcoming book is entitled *The Ballot Question in Nineteenth-Century English Politics*. In collaboration with J.M. and Ann Robson, he is working on a study of J.S. Mill's parliamentary career, with particular emphasis on the Westminster elections of 1865 and 1868. He is co-editor of the *Mill News Letter* and will serve as a co-editor, along with J.M. Robson, of Mill's *Journals and Speeches*, which will be Volumes 24 and 25 of the *Collected Works*.

J.F. MACLEAR is Professor of History at the University of Minnesota, Duluth. His earlier writings have centered on the seventeenth-century religious history of England, Scotland, and New England. Current research focuses on early nineteenth-century Nonconformity and will result in several articles on the transatlantic interdependency of British and American evangelicals. An earlier article in this series appeared as "The Evangelical Alliance and the Antislavery Crusade," *The Huntington Library Quarterly*, XLII (Spring, 1979).

STEPHANIE L. MOOERS is a doctoral candidate in Anglo-Norman history at the University of California, Santa Barbara. The article appearing in this issue was awarded that history department's Ellison Prize for the best paper written by a graduate student in 1979 and was later delivered at the 1980 Berkeley Pacific Coast Conference on British Studies. Her current area of research and the topic of her dissertation is "Patronage and Justice in the Pipe Roll of 1130."

ARTHUR S. WILLIAMS is Assistant Professor of English at South Carolina State College. He is the author of an article on literary relationships in the reigns of William III and Anne, to be published by *Papers on Language and Literature*. At present he is working on a study of the relationship between politics and literature in the career of Joseph Addison.

STEVEN ZWICKER is Associate Professor of English at Washington University, St. Louis. He has written on Marvell, Dryden, and politics and poetry in the later seventeenth century. In 1981-82 he will be a fellow at the Institute for Advanced Study, Princeton.
