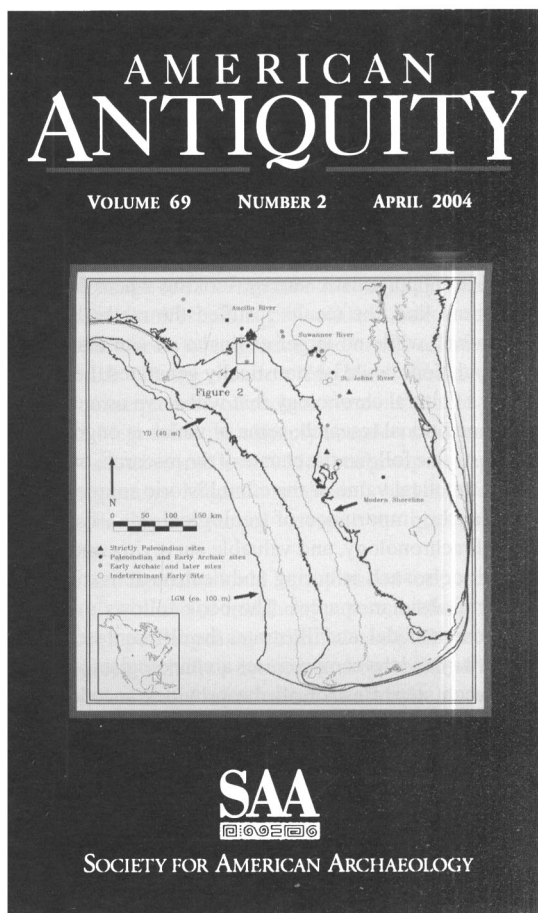

Latin American Antiquity publishes original papers on the archaeology, prehistory, and ethnohistory of Latin America, i.e., Mesoamerica, Central America, and South America, together with culturally affiliated adjacent regions. Papers may also treat more general theoretical and methodological issues with relevance to Latin America. Authors submit manuscripts to the editor for consideration as ARTICLES or REPORTS in English, Spanish, or Portuguese. Authors should submit an original and three copies of their manuscripts (including all figures, tables, references, and notes), along with an abstract in both English and Spanish. Detailed information on policy, style, and technical matters of manuscript preparation is given in English in the "Editorial Policy, Information for Authors, and Style Guide for *American Antiquity* and *Latin American Antiquity*," which appeared in September 1992 (vol. 3, no. 3) and in Spanish in "Código editorial, información para autores y guía estilística para *American Antiquity* and *Latin American Antiquity*," which appeared in July 1997 (vol. 8, no. 2).
