CENTRO INTERCULTURAL DE DOCUMENTACION SUMMER IN CUERNAVACA, MEXICO

INSTITUTE FOR CONTEMPORARY LATIN AMERICAN STUDIES at CIDOC offers the student and faculty member an unusual approach to the understanding of modern man as he experiences social change in hope, creation and frustration.

CIDOC wants to serve colleagues anywhere who are concerned with the human experience of living in Latin America. To focus their encounters, CIDOC selects a new "theme" each term. Most courses offered by the Institute during the corresponding three-month period deal with this theme. Teachers remain free to choose the topic, issue or problem which they know best, and method and discipline most suited to them.

The 12 to 30 courses offered in a three-month period at CIDOC are taught in seminar style, in 15-class hour units and-whenever possible-in sections of one month duration. Thus, within a short period, the Institute gathers in Cuernavaca more than a dozen specialists each interested (from his own point of view) in the same theme.

RECENT INSTITUTIONAL CHANGE IN LATIN AMERICA is the theme chosen for SUMMER, 1968. Each of the following will direct a 15 -hour seminar.

CIF LANGUAGE SCHOOL aims to teach Spanish as a second language to reach a functionally native fluency. CIDOC maintains in its Archives a growing collection on the impact of ideology on social change in Latin America. From this collection CIDOC publishes two manuscript series, CIDOC DOSSIER and SONDEOS.

Each CIDOC DOSSIER records and examines one public controversy which took place in Latin America since 1950. Controversies are selected for documentation only if ideological doctrinnaire or religious themes were at issue. Each DOSSIER contains all references gathered by the compiler which are available through CIDOC Archives (usually 500-1500 entries per DOSSIER) and 150-700 pages of reproduction of the most critical and least accessible documents.

The DOSSIER is an important instrument for any study of minority movements in developing countries and their behavior, and for the analysis of values, strategies and ideologies which motivate change. And these are indispensible for the understanding of contemporary Latin America: its social psychology, sociology, linguistics and media.

A first series of 100 DOSSIERS is planned for completion by 1972. DOSSIERS are available only to members of CIDOC DOSSIER ASSOCIATION.
