## Corrections:

Professor Leah Middlebrook wishes to make the following corrections to her article, "Tout Mon Office:' Body Politics and Family Dynamics in the verse and epîtres of Marguerite de Navarre," in Vol. 54.4.1 (2001), pp. 1108-41.
