The Scottish Contribution

T. B. SMITH

Q.C., D.C.L., LL.D., F.B.A.

Professor of Civil Law in the University of Edinburgh

At a time when Britain seeks entry to the European Economic Community, Scots Law, which is the law of a country which came out of Europe to go into Britain, could play a vital role as mediator and interpreter between the Civilian heritage of Continental Law and the Anglo-American legal tradition.

The Union of 1707 did not create British Law, except at the centre of the Constitution. Scots Law (largely based on the Civil Law) and English Law continued as two separate systems; but for over 200 years—during which time the British peoples took law to all corners of the earth—the two systems have influenced each other. Scots Law was and still is the paradise of the comparative lawyer and when proper comparative methods were used the results promoted British Justice.

SALMOND on the LAW OF TORTS

Salmond on Torts is one of the great law books of all time. There are over 120 sentences or paragraphs in the text which have been cited with express judicial approval, as distinct from being merely cited in argument or for purposes of reference, and these have been retained unaltered. There are nevertheless changes, sometimes very substantial, to be found on nearly every page of this new edition.

The chapter on dangerous premises has had to be almost entirely rewritten in the light of the Occupiers' Liability Act, 1957, which very much simplified an extremely complex subject.

A full and fair comment on the now notorious Wagon Mound case has been included in the chapter on remoteness of damages, together with references in the appropriate places to the very wide dicta which the judgment contains about the tort of negligence itself. The old cases on remoteness have not yet been discarded, as it was felt desirable to retain them until the House of Lords has spoken clearly on the matter.

For the rest, although brought completely up to date, Salmond appears in the arrangement remembered by the many thousands in all parts of the world, who have been brought up on it. Many more, coming to the subject for the first time, will be grateful for the sheer readability of the book.
