NOTES ON THE CONTRIBUTORS

RICHARD R. FAGEN is Professor of Political Science at Stanford University. He has written extensively on both Cuban and Mexican politics and has lived in both countries, as well as in Chile during 1972–73. His most recent book is *Latin America and the United States*, edited with Julio Cotler. He is currently working on U.S. foreign policy, with special emphasis on the possibilities and limits of change in U.S. policy toward the Third World.

JAMES A. MORRIS has been Visiting Assistant Professor at New Mexico State University and Lecturer in Political Science at the Imperial Valley Campus of San Diego State University. He is currently engaged in a study of the emergence of the peasantry as a political actor in Honduras.

STEVE ROPP is Assistant Professor of Political Science at New Mexico State University. He is the author of a number of articles on Central American politics, and is currently doing research on comparative center-periphery relations.

IVAN A. SCHULMAN is Graduate Research Professor of Latin American Literature at the University of Florida. He has published several books on José Martí and numerous studies on modern and contemporary Cuban literature. His most recent publication is a monograph on the *Revista Ilustrada de Nueva York*.

ERICA MILES is completing her doctoral studies at the University of Florida and plans to do her dissertation on the nineteenth-century Cuban narrative.

JERALD FOSTER is Assistant Professor of Spanish American Literature at the University of North Carolina, Chapel Hill. He has written articles on the Spanish American short story and is presently doing research on the Argentine short story.

MARY JEANNE REID MARTZ is Assistant Professor of Political Science at Clemson University, on leave at the University of Wisconsin, Madison for 1976–77 as a National Endowment for the Humanities Fellow. She has traveled and researched extensively in Latin America and has written on Latin American foreign policies and the OAS.

D. NEIL SNARR is Associate Professor of Sociology at Wilmington College, Ohio. He and **E. LEONARD BROWN** have published several articles on Central America and are currently doing a longitudinal study of housing built for victims of hurricane Fifi in Honduras.
