Consisting of constitutive material regarding the establishment and functioning of peace-keeping forces, such as enabling resolutions, Status of Forces Agreements, Participating States Agreements and Force Regulations, this is an up-to-date reference work for legal practice, teaching and research purposes.

The most recent United Nations operations of the 1970's and 1980's (UNEF "II", UNDOF, UNIFIL and UNTAG) are included in addition to the earlier "classic" operations of the 1950's and 1960's (UNEF, ONUC, UNSF and UNFICYP). The book also contains documents on the two so-called multinational forces which were sent to the Middle East in 1982 and are alternatives to United Nations forces which could not be established due to lack of agreement in the Security Council: MFO in Sinaï and MNF in Beirut.
