With some 60 photographs and graphics, this is a brilliant work of historical scholarship and a magnificent example of the efficacy of oral tradition as a research method. More importantly, it demonstrates that there is a solid foundation of intelligence and goodwill on which to build a new South Africa. The Politics of Official Discourse in Twentieth-Century South Africa

ADAM ASHFORTH, *Baruch College, City University of New York*

This study uses a close reading of a series of major commission reports into the "Native Question" to examine the formation and reproduction of state power in South Africa. Analyzing the framework governing authoritative ways of speaking of, for, and to Blacks (once called "Natives"), Ashforth demonstrates how officially-approved forms of knowledge of "Native Life" substitute for political representation by Africans and continually serve to justify repression. Tracing the history of official discourse on the political status of African labor, the work illuminates the central contradictions in the politics of this repressive and exploitative regime.

This is the first English translation of a traditional history of the eighteenth- and nineteenth-century Bamana kingdom of Segu, which flourished in an area that was once part of the Mali Empire and which far outlasted its neighbors in resistance to Islam. The story, which is one of Africa's great epic traditions, offers a view of daily life in Bamana Segu. Tayiru Banbera adds to this, providing invaluable information on such diverse topics as military strategy, culinary practices, taxation, law enforcement, and seduction.

From Apartheid to Nation Building

This book studies apartheid—its background, ideology, implementation, and function—and reform-apartheid, the South African government's latest solution to the continuing crisis. Part One demonstrates that the apartheid system was not unique; rather, that it was built upon the segregation order which had developed as South Africa industrialized with the discovery of diamonds and gold. Part Two critically examines the current South African situation and addresses possibilities for a resolution to the present conflict.

Asante and the Dutch, 1744-1873

LARRY W. YARAK, *Texas A&M University*

This is a careful study of the administration and government of the West African kingdom of Asante between 1744 and 1873. Yarak analyzes the nature and development of the pre-colonial state, and traces the history and character of the Asante-Dutch relationship. Drawing on extensive research in previously neglected Dutch archives, as well as on important Asante oral sources, this book broadens our knowledge of the complexities of Afro-European relations on the pre-colonial Gold Coast, and contributes to wider historiographical debates over our understanding of African institutions.

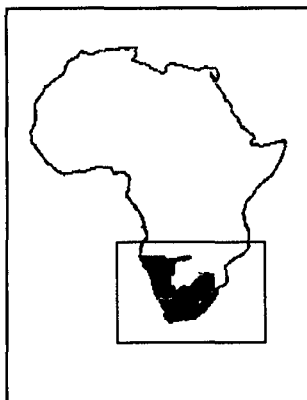

Studies the wood fuel problem in the Kano region of northern Nigeria. Accelerated urban development and population growth have intensified pressure on wood-cutting; this impact on a seasonally arid ecosystem has been compounded by 20 years of below-average rainfall; in addition, Nigeria's oil boom has brought with it not only increased urbanization but also inflation, so that the supply of wood fuel must be obtained at ever greater costs and distances. 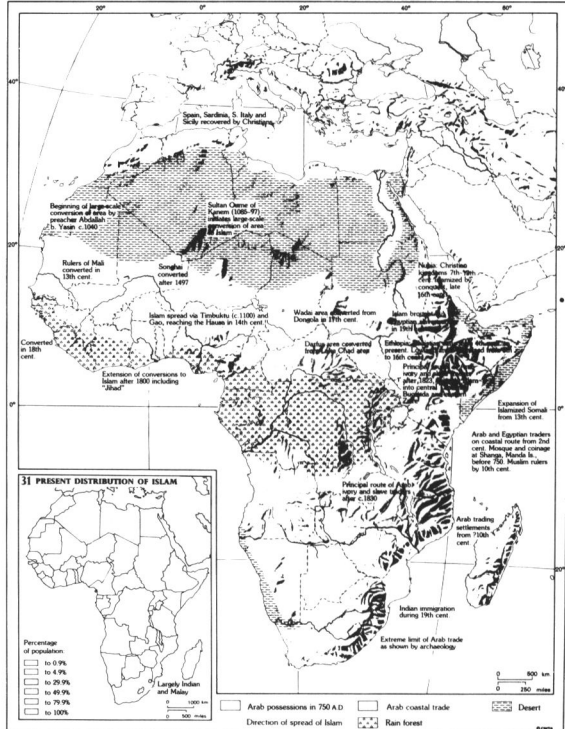
