EDITORIAL POLICY AND PRACTICES

Theatre Survey is chartered by the American Society for Theatre Research as a theatre history journal. This historical orientation, broadly conceived, includes most performance-oriented studies, regardless of cultural or critical methodology, as well as historiographic studies. Studies of dramatic literature generally are outside the purview of the journal unless those studies contain references to actual performance.

Articles submitted are subject to a juried review by members of the American Society for Theatre Research; this process takes about three months. Usually, manuscripts should be between 15 and 50 pages in length. All manuscripts should be prepared according to the *Chicago Manual of Style* (14th Edition) and should be provided both on disk, preferably in WordPerfect 5.1 + or in another IBM-based software application, and in two hard copies (to facilitate juried review). Illustrations are welcomed. A self-addressed, stamped envelope is required for return of manuscript and/or disk.
