## RECIPROCITY AGREEMENTS

The Australian Mathematical Society has made Reciprocity Agreements with the American Mathematical Society, the Edinburgh Mathematical Society, the London Mathomatical Socioty, the Deutsche Mathematiker Vereinigung and the Islenzka Staerdfraedafelagid using the agreoment with the American Mathematical Society as a model. Under this agreement, members of these societies not normally resident in Australia may join the Australian Mathematical Society at half the current rates. Such members will not have the right to vote in the Society or have any other financial commitment. They will receive copies of the Journal free.
