Editorial Intent

One of the most rapidly evolving areas of employment law is that of individual employment rights. Its subject matter is equally varied, including such diverse matters as record keeping and disclosure, health and safety, fair employment practices, alcohol and drug abuse, AIDS, medical screening, employee surveillance, wage and hour standards, union-management relations, employment contracts, dispute contracts, dispute resolution, etc.
