



Authors are requested to forward four copies of their manuscripts together with four copies of an abstract of 100 words. Manuscripts should not be longer than 35 pages (all material included). All material must be double-spaced. Footnotes should be double-spaced and placed in a single listing at the end of the paper. Tables and diagrams must be submitted on separate pages. In preparing a manuscript for consideration by the Editorial Board, authors should follow the JOURNAL's style sheet which the editors can supply. Otherwise, the most recent issue of the JOURNAL can serve as a style guide. Manuscripts will not be returned. Authors may submit the final version on MS-DOS diskette in either DOS text format or WordPerfect, along with a hard copy of the file.
