CONGRUENCES ON ORTHODOX SEMIGROUPS WITH ASSOCIATE SUBGROUPS

If S is a regular semigroup then an inverse transversal of S is an inverse subsemigroup T with the property that $|T \cap V(x)| = 1$ for every $x \in S$ where V(x) denotes the set of inverses of $x \in S$. In a previous publication [1] we considered the similar concept of a subsemigroup T of S such that $|T \cap A(x)| = 1$ for every $x \in S$ where $A(x) = \{y \in S; xyx = x\}$ denotes the set of associates (or pre-inverses) of $x \in S$, and showed that such a subsemigroup T is necessarily a maximal subgroup H_{α} for some idempotent $\alpha \in S$. Throughout what follows, we shall assume that S is orthodox and α is a middle unit (in the sense that $x\alpha y = xy$ for all $x, y \in S$). Under these assumptions, we obtained in [1] a structure theorem which generalises that given in [3] for uniquely unit orthodox semigroup T as $H_{\alpha} = \{x^*; x \in S\}$, which we call an associate subgroup of S. For every $x \in S$ we therefore have $x^*\alpha = x^* = \alpha x^*$ and $x^*x^{**} = \alpha = x^*x^*$. As shown in [1, Theorems 4, 5] we also have $(xy)^* = y^*x^*$ for all $x, y \in S$, and $e^* = \alpha$ for every idempotent e.

Our objective here is to consider congruences on such a semigroup. Since the building bricks in the structure theorem [1] are the subgroup H_{α} and the sub-bands αE , $E\alpha$ of the band E of idempotents of S, these three subsemigroups will play an important rôle in what follows.

As we shall see, the study of congruences is intimately related to certain residuated mappings that arise naturally. We recall that if A, B are ordered sets then a mapping $f: A \rightarrow B$ is said to be *residuated* if the pre-image of every principal down-set of B is a principal down-set of A. For the general properties of residuated mappings we refer the reader to [2]. For our purposes here we require the fact that $f: A \rightarrow B$ is residuated if and only if it is isotone and there is a (necessarily unique) isotone mapping $f^+: B \rightarrow A$ such that $f^+ \circ f \ge id_A$ and $f \circ f^+ \le id_B$.

Since, in the semigroups under consideration, the unary operation $x \mapsto x^*$ is significant, it is reasonable to expect that an important rôle will be played by the semigroup congruences ϑ such that

$$(x, y) \in \vartheta \Rightarrow (x^*, y^*) \in \vartheta,$$

i.e. the congruences on the algebra (S, ., *) which we shall refer to as *-congruences. We shall denote by Con S the complete lattice of (semigroup) congruences on S. It is easily seen that the set of *-congruences forms a complete sublattice of Con S; we denote this by Con*S.

DEFINITION. Let λ , π , μ be congruences on αE , H_{α} , $E\alpha$ respectively. We shall call the triple (λ, π, μ) weighted if there exists $\Theta \in \text{Con } S$ such that

(a) $\Theta|_{H_{\alpha}} = \pi;$

(b) $\lambda \Big|_{\alpha E \alpha}^{n} = \mu \Big|_{\alpha E \alpha} = \Theta \Big|_{\alpha E \alpha}$.

We shall denote by WT(S) the set of weighted triples on S. Given $(\lambda, \pi, \mu) \in WT(S)$ let $\Psi(\lambda, \pi, \mu)$ be the relation on S given by

$$(x, y) \in \Psi(\lambda, \pi, \mu) \Leftrightarrow (x^*x, y^*y) \in \lambda, (x^*, y^*) \in \pi, (xx^*, yy^*) \in \mu.$$

THEOREM 1. If $(\lambda, \pi, \mu) \in WT(S)$ then $\Psi(\lambda, \pi, \mu) \in Con^*S$.

Proof. Suppose that $\Theta \in \text{Con } S$ satisfies (a), (b) and let $(x, y) \in \Psi(\lambda, \pi, \mu)$. Then $(x^*, y^*) \in \pi$ and so, by (a), we have $(x^*, y^*) \in \Theta$ and $(x^{**}, y^{**}) \in \Theta$. It follows that, for every $z \in S$,

$$(x^{**}zz^{*}x^{*}, y^{**}zz^{*}y^{*}) \in \Theta$$

Since each side of this belongs to $\alpha E \alpha$ we then have, by (b),

$$(x^{**}zz^{*}x^{*}, y^{**}zz^{*}y^{*}) \in \mu.$$
(*)

Now

$$x_{z}(x_{z})^{*} = x_{zz}^{*}x^{*} = x_{\alpha zz}^{*}x^{*} = xx^{*} \cdot x^{**}zz^{*}x^{*}$$

and so, by (*) and the fact that $(xx^*, yy^*) \in \mu$, we deduce that

$$(xz(xz)^*, yz(yz)^*) \in \mu$$

Observe also that $(x^*x, y^*y) \in \lambda$ gives

$$(x^*x\alpha, y^*y\alpha) \in \lambda \big|_{\alpha E\alpha} = \Theta \big|_{\alpha E\alpha}$$

whence, for every $z \in S$,

$$(z^*x^*xz^{**}, z^*y^*yz^{**}) \in \Theta|_{\alpha E\alpha} = \lambda|_{\alpha E\alpha}$$

and consequently

$$(z^*x^*xz^{**}z^*z, z^*y^*yz^{**}z^*z) \in \lambda,$$

which reduces to $((xz)^*xz, (yz)^*yz) \in \lambda$. Since clearly $((xz)^*, (yz)^*) = (z^*x^*, z^*y^*) \in \pi$ it follows that $(xz, yz) \in \Psi(\lambda, \pi, \mu)$. In a similar way we can show that $(zx, zy) \in \Psi(\lambda, \pi, \mu)$. Hence $\Psi(\lambda, \pi, \mu)$ is a congruence.

Now $x^*x^{**} = \alpha = x^{**}x^*$ for every $x \in S$ and, since π is a group congruence, we have

$$(x^*, y^*) \in \pi \Rightarrow (x^{**}, y^{**}) = ((x^*)^{-1}, (y^*)^{-1}) \in \pi$$

It follows that $(x^*, y^*) \in \Psi(\lambda, \pi, \mu)$ and therefore $\Psi(\lambda, \pi, \mu)$ is a *-congruence.

In what follows we shall assume that the set WT(S) of weighted triples on S is given the cartesian order.

THEOREM 2. The mapping $\Psi: WT(S) \rightarrow Con S$ is injective and residuated, with residual Ψ^+ given by

$$\Psi^+(\vartheta) = (\vartheta|_{\alpha E}, \vartheta|_{H_{\alpha}}, \vartheta|_{E\alpha}).$$

Moreover, WT(S) is a lattice that is isomorphic to $Con^* S$.

Proof. With notation as above, observe that

$$(x^*, y^*) \in \Psi(\lambda, \pi, \mu) \Leftrightarrow (x^{**}, y^{**}) \in \pi \Leftrightarrow (x^*, y^*) \in \pi,$$

and that therefore $\Psi(\lambda, \pi, \mu)|_{H_{\alpha}} = \pi$.

Also, for $e\alpha \in E\alpha$ we have

$$(e\alpha)^* = \alpha^* e^* = \alpha \alpha = \alpha, \quad (e\alpha)^* e\alpha = \alpha e\alpha \in \alpha E\alpha, \quad e\alpha (e\alpha)^* = e\alpha.$$

These equalities, together with (b), show that

$$(e\alpha, f\alpha) \in \Psi(\lambda, \pi, \mu) \Leftrightarrow (e\alpha, f\alpha) \in \mu$$

and that therefore $\Psi(\lambda, \pi, \mu)|_{E\alpha} = \mu$. Similarly, $\Psi(\lambda, \pi, \mu)|_{\alpha E} = \lambda$.

It follows from these observations that

$$\Psi^{+}\Psi(\lambda,\pi,\mu) = (\lambda,\pi,\mu). \tag{1}$$

Moreover, using the identity $x = xx^*x^{**}x^*x$ and the fact that $\vartheta|_{H_o}$ is a group congruence, we have that

$$\begin{aligned} (x,y) \in \Psi \Psi^+(\vartheta) & \Rightarrow (x^*x, y^*y) \in \vartheta \big|_{\alpha E}, (x^*, y^*) \in \vartheta \big|_{H_a}, (xx^*, yy^*) \in \vartheta \big|_{E_\alpha} \\ & \Rightarrow (x,y) = (xx^*x^{**}x^*x, yy^*y^{**}y^*y) \in \vartheta, \end{aligned}$$

and therefore

$$\Psi\Psi^+(\vartheta)\subseteq\vartheta.\tag{2}$$

Since both Ψ and Ψ^+ are isotone, it follows from (1) and (2) that Ψ is injective and residuated, with residual Ψ^+ .

By Theorem 1 we have that $\operatorname{Im} \Psi \subseteq \operatorname{Con}^* S$. Conversely, if $\vartheta \in \operatorname{Con}^* S$ then $(x, y) \in \vartheta$ gives $(x^*x, y^*y) \in \vartheta$, $(x^*, y^*) \in \vartheta$, $(xx^*, yy^*) \in \vartheta$ whence $(x, y) \in \Psi\Psi^+(\vartheta)$. Thus $\vartheta \subseteq \Psi\Psi^+(\vartheta)$ and it follows from (2) that $\vartheta = \Psi\Psi^+(\vartheta) \in \operatorname{Im} \Psi$. Consequently, $\operatorname{Im} \Psi = \operatorname{Con}^* S$. Now since Ψ is isotone and injective it induces an isotone bijection $\Psi_*: WT(S) \to \operatorname{Im} \Psi$. It follows from the above that the restriction of Ψ^+ to $\operatorname{Con}^* S$ is isotone and is the inverse of Ψ_* . Consequently, $WT(S) \simeq \operatorname{Im} \Psi$. It follows from these observations that WT(S) is isomorphic to the lattice $\operatorname{Con}^* S$.

COROLLARY 1. The relation \equiv defined on Con S by

$$\vartheta \equiv \varphi \Leftrightarrow \vartheta \big|_{\alpha E} = \varphi \big|_{\alpha E}, \qquad \vartheta \big|_{H_{\alpha}} = \varphi \big|_{H_{\alpha}}, \qquad \vartheta \big|_{E\alpha} = \varphi \big|_{E\alpha}$$

is a dual closure equivalence. The smallest element in the =-class of ϑ is $\Psi\Psi^+(\vartheta)$.

Proof. Observe that, since Ψ is residuated, $\Psi\Psi^+$ is a dual closure; and, since $\Psi^+\Psi\Psi^+=\Psi^+$,

$$\vartheta \equiv \varphi \Leftrightarrow \Psi^+(\vartheta) = \Psi^+(\varphi) \Leftrightarrow \Psi \Psi^+(\vartheta) = \Psi \Psi^+(\varphi).$$

COROLLARY 2. There is a lattice isomorphism $\dot{Con}^* S \simeq (Con S) = .$

COROLLARY 3. If (λ, π, μ) , $(\lambda', \pi', \mu') \in WT(S)$ then

$$\Psi(\lambda,\pi,\mu)\cap\Psi(\lambda',\pi',\mu')=\Psi(\lambda\cap\lambda',\pi\cap\pi',\mu\cap\mu');$$

$$\Psi(\lambda, \pi, \mu) \vee \Psi(\lambda', \pi', \mu') = \Psi(\lambda \vee \lambda', \pi \vee \pi', \mu \vee \mu').$$

Proof. This follows immediately from the fact that $(\lambda, \pi, \mu) \mapsto \Psi(\lambda, \pi, \mu)$ is a lattice isomorphism from WT(S) to Con* S.

We now consider the extension of congruences on αE , H_{α} , $E\alpha$ to *-congruences on

S. We begin with the subgroup H_{α} . For this purpose we shall use the notation ι_X to denote the universal congruence on a given subset X of S.

THEOREM 3. For every $\vartheta \in \text{Con } H_{\alpha}$ the relation $\hat{\vartheta}$ defined on S by

$$(a,b) \in \hat{\vartheta} \Leftrightarrow (a^*,b^*) \in \vartheta$$

is the biggest *-congruence on S whose restriction to H_{α} is ϑ . The weighted triple that corresponds to $\hat{\vartheta}$ is $(\iota_{\alpha E}, \vartheta, \iota_{E\alpha})$.

Proof. If $(a, b) \in \hat{\vartheta}$ then $(a^*, b^*) \in \vartheta$ and therefore, since ϑ is a congruence on the group H_{α} , we have $(a^*x^*, b^*x^*) \in \vartheta$ for every $x \in S$. Since $a^*x^* = (xa)^*$ it follows that $(xa, xb) \in \hat{\vartheta}$. Similarly, $(ax, bx) \in \hat{\vartheta}$ and so $\hat{\vartheta} \in \text{Con } S$. Since $(a^*, b^*) \in \vartheta$ implies $(a^{**}, b^{**}) \in \vartheta$ it follows that $\hat{\vartheta}$ is a *-congruence. Now if $a, b \in H_{\alpha}$ we have that

$$(a,b) \in \hat{\vartheta}|_{H_a} \Leftrightarrow (a^*,b^*) \in \vartheta \Leftrightarrow (a,b) = (a^{**},b^{**}) \in \vartheta$$

and consequently we see that $\hat{\vartheta}|_{H_o} = \vartheta$. If now φ is a *-congruence such that $\varphi|_{H_o} = \vartheta$ then

$$(a,b) \in \varphi \Rightarrow (a^*,b^*) \in \varphi|_{H_1} = \vartheta \Rightarrow (a,b) \in \hat{\vartheta},$$

so that $\varphi \subseteq \hat{\vartheta}$. Since $e^* = \alpha$ for every $e \in \alpha E \cup E\alpha$ is clear that $\hat{\vartheta}|_{\alpha E} = \iota_{\alpha E}$ and $\hat{\vartheta}|_{E\alpha} = \iota_{E\alpha}$. It follows that the weighted triple that corresponds to $\hat{\vartheta}$ is $\Psi^+(\hat{\vartheta}) = (\iota_{\alpha E}, \vartheta, \iota_{E\alpha})$.

COROLLARY. Every $\vartheta \in \text{Con } H_{\alpha}$ is the middle component of some weighted triple. The biggest *-congruence that corresponds to a weighted triple of the form $(-, \vartheta, -)$ is $\hat{\vartheta}$.

THEOREM 4. The mapping Ω : Con* $S \to$ Con H_{α} given by $\Omega(\varphi) = \varphi|_{H_{\alpha}}$ is surjective and residuated, with residual Ω^+ given by $\Omega^+(\vartheta) = \hat{\vartheta}$.

Proof. Each of Ω and Ω^+ as defined is isotone and, for all $\varphi \in \text{Con}^* S$ and all $\vartheta \in \text{Con} H_{\alpha}$,

$$\Omega^{+}\Omega(\varphi) = \Omega^{+}(\varphi|_{H_{\alpha}}) = \widehat{\varphi}|_{H_{\alpha}} \ge \varphi;$$

$$\Omega\Omega^{+}(\vartheta) = \Omega(\widehat{\vartheta}) = \widehat{\vartheta}|_{H_{\alpha}} = \vartheta.$$

COROLLARY. Con H_{α} is isomorphic to the sublattice of Con*S consisting of those *-congruences φ such that $\varphi|_{\alpha E} = \iota_{\alpha E}$ and $\varphi|_{E\alpha} = \iota_{E\alpha}$.

Proof. Since Ω^+ is injective the sublattice in question is Im Ω^+ . Now we have $\Omega^+\Omega\Omega^+ = \Omega^+$ and so Im $\Omega^+ = \text{Im } \Omega^+\Omega$, which consists of those *-congruences φ such that $\varphi = \widehat{\varphi}|_{H_{\alpha}}$. The conclusion follows from Theorem 3.

We now consider extensions of congruences on αE and $E\alpha$. For this purpose we require the fact that if $e \in E$ then for every $x \in S$ we have $x^*ex \in E$ and $xex^* \in E$. Indeed, by [1, Corollary 1 of Theorem 5] we have that $e^* = \alpha$ for every $e \in E$ and therefore $x^*ex = x^*\alpha ex = x^*e^*ex = (ex)^*ex \in E$ and similarly $xex^* \in E$.

DEFINITION. We shall say that $\lambda \in \text{Con } \alpha E$ is special if, for all $e, f \in \alpha E$,

$$(e,f) \in \lambda \Rightarrow (\forall x \in S) \qquad (x^*ex, x^*fx) \in \lambda.$$

Similarly, $\mu \in \text{Con } E\alpha$ will be called *special* if, for all $e, f \in E\alpha$,

$$(e, f) \in \mu \Rightarrow (\forall x \in S) \qquad (xex^*, xfx^*) \in \mu.$$

In what follows, given $\lambda \in \text{Con } \alpha E$ we shall be interested in the relation $\overline{\lambda}$ defined on S by

 $(a,b) \in \overline{\lambda} \Leftrightarrow (\forall e \in R) \quad (a^*ea, b^*eb) \in \lambda;$

and dually, for $\mu \in \text{Con } E\alpha$, the relation $\overline{\mu}$ defined on S by

$$(a,b) \in \tilde{\mu} \Leftrightarrow (\forall e \in E)$$
 $(aea^*, beb^*) \in \mu.$

Note that $\overline{\lambda}$ is a left congruence on S; for if $(a, b) \in \overline{\lambda}$ then, since $x^*ex \in E$ for every $x \in S$, we have $(a^*x^*exa, b^*x^*exb) \in \lambda$, so that $(xa, xb) \in \overline{\lambda}$. Similarly, $\overline{\mu}$ is a right congruence.

THEOREM 5. For $\lambda \in \text{Con } \alpha E$ the following statements are equivalent:

(1) λ is special;

(2) $\lambda = \vartheta|_{\alpha E}$ for some $\vartheta \in \text{Con } S$.

Proof. (1) \Rightarrow (2). Suppose that λ is special. Then we have $\overline{\lambda} \in \text{Con } S$. For, if $(a, b) \in \overline{\lambda}$ then, since λ is special and $a^*ea \in \alpha E$, for every $x \in S$ we have $(x^*a^*eax, x^*b^*ebx) \in \lambda$, so that $(ax, bx) \in \overline{\lambda}$, whence $\overline{\lambda}$ is a right congruence. As observed above, $\overline{\lambda}$ is a left congruence.

If now $f, g \in \alpha E$ are such that $(f, g) \in \overline{\lambda}$ then since $f^* = g^* = \alpha$ we have $(\alpha ef, \alpha eg) \in \lambda$ for every $e \in E$. Taking $e = \alpha$ we obtain $(f, g) \in \lambda$. Conversely, if $(f, g) \in \lambda$ then $(\alpha ef, \alpha eg) \in \lambda$ gives $(f^*ef, g^*eg) \in \lambda$ whence $(f, g) \in \overline{\lambda}$. Hence $\overline{\lambda}|_{\alpha E} = \lambda$, so (2) holds with $\vartheta = \overline{\lambda}$.

 $(2) \Rightarrow (1)$. If $\vartheta \in \text{Con } S$ then for $e, f \in \alpha E$ we have

$$(e,f) \in \vartheta|_{\alpha E} \Rightarrow (e,f) \in \vartheta \Rightarrow (\forall x \in S) \ (x^*ex, x^*fx) \in \vartheta.$$

Since $x^*ex \in \alpha E$, it follows that $\vartheta|_{\alpha E}$ is special.

COROLLARY 1. For every special congruence λ on αE there is a biggest *-congruence ϑ on S such that $\vartheta|_{\alpha E} = \lambda$, namely $\vartheta = \Psi \Psi^+(\overline{\lambda})$.

Proof. By Theorem 2, $\Psi \Psi^+(\overline{\lambda}) \in \operatorname{Con}^* S$ with $\Psi \Psi^+(\overline{\lambda})|_{\alpha E} = \overline{\lambda}|_{\alpha E} = \lambda$. If now $\zeta \in \operatorname{Con}^* S$ is such that $\zeta|_{\alpha E} = \lambda$ then

$$(a,b) \in \zeta \Rightarrow (\forall e \in E) \ (a^*ea, b^*eb) \in \zeta|_{\alpha E} = \lambda \Rightarrow (a,b) \in \overline{\lambda},$$

so $\zeta \subseteq \overline{\lambda}$ and consequently $\zeta = \Psi \Psi^+(\zeta) \subseteq \Psi \Psi^+(\overline{\lambda})$.

COROLLARY 2. The following statements concerning $\lambda \in \text{Con } \alpha E$ are equivalent:

(1) λ is special;

(2) there is a weighted triple whose first component is λ .

Proof. (1) \Rightarrow (2). If (1) holds then the weighted triple associated with $\Psi \Psi^+(\bar{\lambda})$ has first component λ .

 $(2) \Rightarrow (1)$. If there is a weighted triple of the form $(\lambda, -, -)$ then by Theorem 2 we have

$$(\lambda, -, -) = \Psi^+ \Psi(\lambda, -, -)$$

whence $\lambda = \Psi(\lambda, -, -)|_{\alpha E}$ and so λ is special.

Let SpCon αE be the set of special congruences on αE . It is immediate from Corollary 2 above and the fact that WT(S) is a lattice that SpCon αE is a sublattice of Con αE .

THEOREM 6. The mapping $\Phi_{\alpha E}$: Con* $S \to \text{SpCon } \alpha E$ given by $\Phi_{\alpha E}(\vartheta) = \vartheta|_{\alpha E}$ is surjective and residuated, with residual $\Phi_{\sigma F}^+$ given by $\Phi_{\sigma F}^+(\lambda) = \Psi \Psi^+(\overline{\lambda})$.

Proof. Each of $\Phi_{\alpha F}$ and $\Phi_{\alpha F}^{+}$ as defined is isotone. For every $\vartheta \in \text{Con}^* S$ we have

$$\Phi_{\alpha E}^{+}\Phi_{\alpha E}(\vartheta) = \Phi_{\alpha E}^{+}(\vartheta|_{\alpha E}) = \Psi\Psi^{+}(\overline{\vartheta|_{\alpha E}}) \geq \vartheta$$

since, by the Corollary to Theorem 5, $\Psi\Psi^+(\overline{\vartheta|_{\alpha E}})$ is the biggest *-congruence on S whose restriction to αE is $\vartheta|_{\alpha E}$. Also, for every $\lambda \in \text{SpCon } \alpha E$ we have

$$\Phi_{\alpha E} \Phi_{\alpha E}^{+}(\lambda) = \Phi_{\alpha E} \Psi \Psi^{+}(\overline{\lambda}) = \Psi \Psi^{+}(\overline{\lambda}) |_{\alpha E} = \overline{\lambda} |_{\alpha E} = \lambda.$$

Hence $\Phi_{\alpha E}$ is surjective and residuated, with residual $\Phi_{\alpha E}^+$.

There is, of course, a dual to Theorem 6 that involves $E\alpha$.

THEOREM 7. Let $\lambda \in \text{Con } \alpha E$ and $\mu \in \text{Con } E \alpha$. Then the following statements are equivalent:

(1) λ , μ are the first and third components of some common weighted triple;

(2) λ, μ are special and $\lambda|_{\alpha E \alpha} = \mu|_{\alpha E \alpha}$.

Proof. (1) \Rightarrow (2). If $(\lambda, \pi, \mu) \in WT(S)$ then λ and μ are special by Corollary 2 of Theorem 5 and, from the definition of weighted triple, $\lambda|_{\alpha E\alpha} = \mu|_{\alpha E\alpha}$. (2) \Rightarrow (1). Observe that since $\overline{\lambda} \in \text{Con } S$ and $\lambda = \overline{\lambda}|_{\alpha E}$ we have, for all $p, q \in E$,

$$\begin{aligned} (\alpha p, \alpha q) &\in \lambda \Rightarrow (\alpha p, \alpha q) \in \lambda \\ \Rightarrow (\forall e \in E) \quad (\alpha p e \alpha, \alpha q e \alpha) \in \overline{\lambda} \Big|_{\alpha E \alpha} = \lambda \Big|_{\alpha E \alpha} = \mu \Big|_{\alpha E \alpha} \\ \Rightarrow (\alpha p, \alpha q) \in \overline{\mu}. \end{aligned}$$

Consequently, $\lambda \subseteq \overline{\mu}|_{\alpha E}$; and similarly $\mu \subseteq \overline{\lambda}|_{E\alpha}$.

For $a, b \in H_{\alpha}$ we have

$$(a,b) \in \overline{\lambda}\Big|_{H_{a}} \Leftrightarrow (\forall e \in E) \quad (a^{*}ea, b^{*}eb) \in \lambda\Big|_{\alpha E\alpha} = \mu\Big|_{\alpha E\alpha} \Leftrightarrow (a^{*}, b^{*}) \in \overline{\mu}\Big|_{H_{a}},$$

this being equivalent to $(a, b) \in \overline{\mu}|_{H_a}$, so that $\overline{\lambda}|_{H_a} = \overline{\mu}|_{H_a}$.

Now, under the *-congruence/weighted triple bijection of Theorem 2, we have

$$\Psi\Psi^+(\bar{\lambda})\sim(\lambda,\bar{\lambda}|_{H_a},\bar{\lambda}|_{E\alpha}),\qquad \Psi\Psi^+(\bar{\mu})\sim(\bar{\mu}|_{\alpha E},\bar{\mu}|_{H_a},\mu).$$

Defining $\pi_{\lambda,\mu} = \bar{\lambda}|_{H_a} = \bar{\mu}|_{H_a}$, we see that the *-congruence $\Psi \Psi^+(\bar{\lambda}) \cap \Psi \Psi^+(\bar{\mu})$ corresponds to the weighted triple $(\lambda, \pi_{\lambda,\mu}, \mu)$.

COROLLARY 1. There is a biggest *-congruence that corresponds to a weighted triple of the form $(\lambda, -, \mu)$, namely $\Psi \Psi^+(\bar{\lambda}) \cap \Psi \Psi^+(\bar{\mu})$.

Proof. For $(\lambda, \pi, \mu) \in WT(S)$, let $\Theta \in Con S$ satisfy (a), (b) and let $P = \Psi(\lambda, \pi, \mu)$.

If $(a^*, b^*) \in \pi$ then we have $(a^{**}, b^{**}) \in \pi$ whence $(a^*, b^*) \in \Theta$ and $(a^{**}, b^{**}) \in \Theta$, from which it follows that

$$(\forall e \in E) \quad (a^*ea^{**}, b^*eb^{**}) \in \Theta|_{\alpha E\alpha} = \lambda|_{\alpha E\alpha}$$

and therefore $(a^{**}, b^{**}) \in \overline{\lambda}$.

Since $\lambda = \overline{\lambda}|_{\alpha E}$ and since, as seen above, $\mu \subseteq \overline{\lambda}|_{E_{\alpha}}$ it follows that

$$(a,b) \in P \Rightarrow (a^*a, b^*b) \in \overline{\lambda}, (a^{**}, b^{**}) \in \overline{\lambda}, (aa^*, bb^*) \in \overline{\lambda}$$
$$\Rightarrow (a,b) \in \overline{\lambda}$$

so $P \subseteq \overline{\lambda}$ and therefore $P = \Psi \Psi^+(P) \subseteq \Psi \Psi^+(\overline{\lambda})$. Arguing similarly with μ , we obtain

$$P \subseteq \Psi \Psi^+(\bar{\lambda}) \cap \Psi \Psi^+(\bar{\mu})$$

from which the result follows.

COROLLARY 2. The biggest weighted triple of the form $(\lambda, -, \mu)$ has middle component $\pi_{\lambda,\mu} = \overline{\lambda}|_{H_a} = \overline{\mu}|_{H_a}$.

Given $\lambda \in \text{SpCon } \alpha E$ and $\mu \in \text{SpCon } E\alpha$, let $T_{\lambda,\mu}$ be the set of weighted triples with first component λ and third component μ . As in the proof of Theorem 7, let $\pi_{\lambda,\mu} = \overline{\lambda}|_{H_{\alpha}} = \overline{\mu}|_{H_{\alpha}}$.

THEOREM 8. $T_{\lambda,\mu}$ is a sublattice of WT(S), isomorphic to the interval $[\omega, \pi_{\lambda,\mu}]$ of Con H_{α} .

Proof. Clearly, $T_{\lambda,\mu}$ is a sublattice of WT(S). If now $(\lambda, \vartheta, \mu) \in T_{\lambda,\mu}$ then by Corollary 2 of Theorem 7 we have $\vartheta \subseteq \pi_{\lambda,\mu}$. Consider the mapping $\zeta: T_{\lambda,\mu} \to [\omega, \pi_{\lambda,\mu}]$ given by $\zeta(\lambda, \vartheta, \mu) = \vartheta$. Clearly, ζ is an injective \cap -morphism. It suffices, therefore, to prove that ζ is surjective; equivalently, that if $\vartheta \in [\omega, \pi_{\lambda,\mu}]$ then $(\lambda, \vartheta, \mu)$ is a weighted triple. Now, by Theorem 3, ϑ is represented by the weighted triple

$$(\iota_{\alpha E}, \vartheta, \iota_{E\alpha}),$$

whereas $\Psi \Psi^+(\bar{\lambda})$ is represented by the weighted triple

$$(\lambda, \pi_{\lambda,\mu}, \overline{\lambda}|_{E\alpha}),$$

and $\Psi\Psi^+(\bar{\mu})$ is represented by the weighted triple

$$(\bar{\mu}|_{\alpha E}, \pi_{\lambda,\mu}, \mu).$$

It follows by Theorem 2 that the *-congruence $\hat{\vartheta} \cap \Psi \Psi^+(\bar{\lambda}) \cap \Psi \Psi^+(\bar{\mu})$ is represented by the intersection of these three triples which, since $\lambda \subseteq \bar{\mu}|_{\alpha E}$ and $\mu \subseteq \bar{\lambda}|_{E\alpha}$, is $(\lambda, \vartheta, \mu)$.

COROLLARY. For every $(\lambda, \vartheta, \mu) \in WT(S)$ we have

$$\Psi(\lambda, \vartheta, \mu) = \hat{\vartheta} \cap \Psi \Psi^+(\bar{\lambda}) \cap \Psi \Psi^+(\bar{\mu}).$$

Given $\varphi \in \operatorname{Con} \alpha E$ consider now the relation λ_{φ} defined on αE by

$$(a,b) \in \lambda_{\varphi} \Leftrightarrow (a\alpha,b\alpha) \in \varphi.$$

Clearly, if $(a, b) \in \lambda_{\varphi}$ then $(xa, xb) \in \lambda_{\varphi}$ for all $x \in \alpha E$; and $ax\alpha = a\alpha x\alpha$ gives $(ax, bx) \in \lambda_{\varphi}$. Thus $\lambda_{\varphi} \in \text{Con } \alpha E$ with, clearly, $\lambda_{\varphi}|_{\alpha E \alpha} = \varphi$. Similarly, if μ_{φ} is defined on $E \alpha$ by

 $(a,b) \in \mu_{\varphi} \Leftrightarrow (\alpha a, \alpha b) \in \varphi$

then $\mu_{\varphi} \in \operatorname{Con} E\alpha$ with $\mu_{\varphi}|_{\alpha E\alpha} = \varphi$.

THEOREM 9. The mapping $\delta_{\alpha E}$: Con $\alpha E \rightarrow$ Con $\alpha E \alpha$ given by $\delta_{\alpha E}(\vartheta) = \vartheta|_{\alpha E \alpha}$ is surjective and residuated, with residual $\delta_{\alpha E}^+$ given by $\delta_{\alpha E}^+(\varphi) = \lambda_{\varphi}$.

Proof. Both $\delta_{\alpha E}$ and $\delta_{\alpha E}^+$ as defined are isotone. Now, for every $\varphi \in \text{Con } \alpha E \alpha$,

$$\delta_{\alpha E} \delta_{\alpha E}^{+}(\varphi) = \delta_{\alpha E}(\lambda_{\varphi}) = \lambda_{\varphi}|_{\alpha E \alpha} = \varphi.$$

Also, if $\vartheta \in \operatorname{Con} \alpha E$ then

$$(a,b) \in \vartheta \Rightarrow (a\alpha,b\alpha) \in \vartheta|_{\alpha E \alpha} \Rightarrow (a,b) \in \lambda_{\vartheta|_{\alpha E \alpha}}$$

so that $\vartheta \subseteq \lambda_{|_{\alpha \in \alpha}}$. Consequently,

$$\delta_{\alpha E}^{+}\delta_{\alpha E}(\vartheta) = \delta_{\alpha E}^{+}(\vartheta|_{\alpha E\alpha}) = \lambda_{\vartheta|_{\alpha E\alpha}} \supseteq \vartheta.$$

Hence $\delta_{\alpha E}$ is surjective and residuated, with residual $\delta_{\alpha E}^+$.

We shall say that $\varphi \in \text{Con } \alpha E \alpha$ is special if

$$(a,b) \in \varphi \Rightarrow (\forall x \in S) \quad (x^*ax\alpha, x^*bx\alpha) \in \varphi, \quad (\alpha xax^*, \alpha xbx^*) \in \varphi.$$

THEOREM 10. The following statements concerning $\varphi \in \text{Con } \alpha E \alpha$ are equivalent:

(1) φ is special;

(2) λ_{φ} and μ_{φ} are special;

(3) there is a weighted triple of the form $(\lambda_{\varphi}, -, \mu_{\varphi})$.

Proof. (1) \Rightarrow (2). Suppose that (1) holds. Then

$$(e,f) \in \lambda_{\varphi} \Rightarrow (e\alpha, f\alpha) \in \varphi \Rightarrow (\forall x \in S) \quad (x^*ex\alpha, x^*fx\alpha) \in \varphi$$
$$\Rightarrow (\forall x \in S) \quad (x^*wx, x^*fx) \in \lambda_{\varphi},$$

so λ_{φ} is special. Similarly, so is μ_{φ} .

(2) \Rightarrow (1). If λ_{ω} and μ_{ω} are special then

$$\begin{aligned} (e,f) &\in \varphi = \lambda_{\varphi} \Big|_{\alpha E \alpha} \Rightarrow (\forall x \in S) \quad (x^* e x, x^* f x) \in \lambda_{\varphi} \\ &\Rightarrow (\forall x \in S) \quad (x^* e x \alpha, x^* f x \alpha) \in \lambda_{\varphi} \Big|_{\alpha E \alpha} = \varphi, \end{aligned}$$

and similarly with μ_{φ} . Hence φ is special.

(2) \Leftrightarrow (3). Since $\lambda_{\varphi}|_{\alpha E \alpha} = \mu_{\varphi}|_{\alpha E \alpha} = \varphi$, this follows by Theorem 7.

If $\varphi_1, \varphi_2 \in \text{Con } \alpha E \alpha$ then it is readily seen that $\lambda_{\varphi_1} \cap \lambda_{\varphi_2} = \lambda_{\varphi_1 \cap \varphi_2}$. Now, with = indicating λ_{φ_1} or λ_{φ_2} and \sim indicating, as appropriate, φ_1 or φ_2 , we have

$$(a, b) \in \lambda_{\varphi_1} \lor \lambda_{\varphi_2} \Leftrightarrow a \equiv x_1 \equiv x_2 \equiv \ldots \equiv x_n \equiv b$$
$$\Leftrightarrow a\alpha \sim x_1\alpha \sim x_2\alpha \sim \ldots \sim x_n\alpha \sim b\alpha$$
$$\Leftrightarrow (a\alpha, b\alpha) \in \varphi_1 \lor \varphi_2$$
$$\Leftrightarrow (a, b) \in \lambda_{\varphi_1 \lor \varphi_2}$$

and therefore $\lambda_{\varphi_1} \vee \lambda_{\varphi_2} = \lambda_{\varphi_1 \vee \varphi_2}$. Similarly we have $\mu_{\varphi_1} \cap \mu_{\varphi_2} = \mu_{\varphi_1 \cap \varphi_2}$ and $\mu_{\varphi_1} \vee \mu_{\varphi_2} = \mu_{\varphi_1 \vee \varphi_2}$. It follows by Theorem 10 that if $\varphi_1, \varphi_2 \in \text{Con } \alpha E \alpha$ are special then so also are $\varphi_1 \cap \varphi_2$ and $\varphi_1 \vee \varphi_2$. Hence the set of special congruences on $\alpha E \alpha$ forms a lattice which we shall denote by SpCon $\alpha E \alpha$.

Note now that if $\lambda \in \text{SpCon } \alpha E$ then $\lambda|_{\alpha E \alpha} \in \text{SpCon } \alpha E \alpha$. In fact,

$$(a, b) \in \lambda \Rightarrow (a\alpha, b\alpha) \in \lambda$$
$$\Rightarrow (\forall x \in S) \quad (x^* a\alpha x, x^* b\alpha x) \in \lambda$$
$$\Rightarrow (\forall x \in S) \quad (x^* ax\alpha, x^* bx\alpha) \in \lambda|_{\alpha E\alpha},$$

and

$$(a,b) \in \lambda \Rightarrow (\forall x \in S) \quad (x^{**}ax^{*}, x^{**}bx^{*}) \in \lambda|_{\alpha \in \alpha} = \mu|_{\alpha \in \alpha}$$
$$\Rightarrow (\forall x \in S) \quad (xax^{*}, xbx^{*}) = (xx^{*}x^{**}ax^{*}, xx^{*}x^{**}bx^{*}) \in \mu$$
$$\Rightarrow (\forall x \in S) \quad (\alpha xax^{*}, \alpha xbx^{*}) \in \mu|_{\alpha \in \alpha} = \lambda|_{\alpha \in \alpha}.$$

This observation, together with Theorems 9 and 10, gives immediately the following result.

THEOREM 11. The mapping $\Delta_{\alpha E}$: SpCon $\alpha E \rightarrow$ SpCon $\alpha E \alpha$ given by $\Delta_{\alpha E}(\vartheta) = \vartheta|_{\alpha E \alpha}$ is surjective and residuated, with residual $\Delta_{\alpha E}^+$ given by $\Delta_{\alpha E}^+(\varphi) = \lambda_{\varphi}$.

Note also that if $\vartheta \in \text{Con } S$ then $\vartheta|_{\alpha E \alpha}$ is special. In fact, by Theorem 5, $\vartheta|_{\alpha E}$ is special and therefore, by the above observation, so is $\vartheta|_{\alpha E \alpha}$. We can therefore use Theorems 6 and 11, and their duals to obtain the following result.

THEOREM 12. The mapping $\Gamma: \operatorname{Con}^* S \to \operatorname{SpCon} \alpha E \alpha$ given by $\Gamma(\vartheta) = \vartheta|_{\alpha E \alpha}$ is surjective and residuated, with residual Γ^+ given by

$$\Gamma^+(\varphi) = \Psi(\lambda_{\varphi}, \pi_{\lambda_{\varphi}, \mu_{\varphi}}, \mu_{\varphi}).$$

Proof. Consider the diagram



which is commutative since, by definition, $\Delta_{\alpha E} \Phi_{\alpha E} = \Gamma = \Delta_{E\alpha} \Phi_{E\alpha}$. That Γ is surjective follows from Theorems 6 and 11. By [2, Theorem 2.8] we have on the one hand, for every $\varphi \in \text{SpCon } \alpha E \alpha$,

$$\Gamma^{+}(\varphi) = \Phi^{+}_{\alpha E} \Delta^{+}_{\alpha E}(\varphi) = \Phi^{+}_{\alpha E}(\lambda_{\varphi}) = \Psi \Psi^{+}(\overline{\lambda_{\varphi}}) = \Psi(\overline{\varphi_{\varphi}}|_{\alpha E}, \overline{\lambda_{\varphi}}|_{H_{a}}, \overline{\lambda_{\varphi}}|_{E\alpha}), \tag{1}$$

and, on the other,

$$\Gamma^{+}(\varphi) = \Phi^{+}_{E\alpha} \Delta^{+}_{E\alpha}(\varphi) = \Phi^{+}_{E\alpha}(\mu_{\varphi}) = \Psi \Psi^{+}(\overline{\mu_{\varphi}}) = \Psi(\overline{\mu_{\varphi}}|_{\alpha E}, \overline{\mu_{\varphi}}|_{H\alpha}, \overline{\mu_{\varphi}}|_{E\alpha}).$$
(2)

Since $\overline{\lambda_{\varphi}}|_{\alpha E} = \lambda_{\varphi}$ and $\overline{\mu_{\varphi}}|_{E\alpha} = \mu_{\varphi}$, it follows from (1), (2) that $\overline{\lambda_{\varphi}}|_{E\alpha} = \overline{\mu_{\varphi}}$ and $\overline{\mu_{\varphi}}|_{\alpha E} = \lambda_{\varphi}$ so that $\Gamma^{+}(\varphi) = \Psi(\lambda_{\varphi}, \pi_{\lambda_{\varphi}, \mu_{\varphi}}, \mu_{\varphi})$ as asserted.

COROLLARY. $\varphi \in \text{Con } \alpha E \alpha$ is special if and only if φ can be extended to a congruence on S.

DEFINITION. We shall say that $\lambda \in \text{Con } \alpha E$ is *unitary* if, in the quotient band $\alpha E/\lambda$, the class $[\alpha]\lambda$ is an identity element.

THEOREM 13. The following statements concerning $\lambda \in \text{Con } \alpha E$ are equivalent:

(1) λ is unitary;

(2) $(\forall a, b \in \alpha E) (a\alpha, b\alpha) \in \lambda |_{\alpha E} \Rightarrow (a, b) \in \lambda.$

Proof. (1) \Rightarrow (2). If λ is unitary then $[a\alpha]\lambda = [a]\lambda[\alpha]\lambda = [a]\lambda$. (2) \Rightarrow (1). If (2) holds then

$$(b, a\alpha) \in \lambda \Rightarrow (b\alpha, a\alpha) \in \lambda |_{\alpha E \alpha} \Rightarrow (b, a) \in \lambda$$

so that $[a\alpha]\lambda \subseteq [a]\lambda$ whence we have equality.

COROLLARY. The set of unitary congruences on αE is a sublattice of Con αE .

Proof. If $\lambda, \lambda' \in \text{Con } \alpha E$ are unitary then it is clear from Theorem 13 that so also is $\lambda \cap \lambda'$. If now $(a\alpha, b\alpha) \in \lambda \lor \lambda'$ then there exist $z_1, \ldots, z_n \in \alpha E$ such that

$$a\alpha \equiv z_1 \equiv z_2 \equiv \ldots \equiv z_n \equiv b\alpha$$

where in each case = signifies either λ or λ' . It follows that

$$a\alpha \equiv z_1 \alpha \equiv z_2 \alpha \equiv \ldots \equiv z_n \alpha \equiv b\alpha$$

and therefore, by Theorem 13, that

$$a \equiv z_1 \equiv z_2 \equiv \ldots \equiv z_n \equiv b.$$

Consequently, $(a, b) \in \lambda \lor \lambda'$ and so $\lambda \lor \lambda'$ is also unitary.

Our interest in unitary congruences stems from the fact that if $\varphi \in \text{Con } \alpha E \alpha$ then λ_{φ} is unitary, as can be seen from Theorem 13 and the equivalences

$$(a\alpha, b\alpha) \in \lambda_{\varphi} \Leftrightarrow (a\alpha, b\alpha) \in \varphi \Leftrightarrow (a, b) \in \lambda_{\varphi}.$$

THEOREM 14. If $\lambda \in \text{Con } \alpha E$ and $\varphi = \lambda|_{\alpha E \alpha}$ then λ_{φ} is the smallest unitary congruence on αE that contains λ .

Proof. Observe that

$$(a,b) \in \lambda \Rightarrow (a\alpha,b\alpha) \in \lambda|_{\alpha E \alpha} = \varphi \Rightarrow (a,b) \in \lambda_{\varphi},$$

so we have $\lambda \subseteq \lambda_{\varphi}$. If now ρ is a unitary congruence on αE such that $\lambda \subseteq \rho$ then

$$(a,b) \in \lambda_{\varphi} \Rightarrow (a\alpha,b\alpha) \in \varphi = \lambda|_{\alpha E\alpha} \subseteq \rho|_{\alpha E\alpha} \Rightarrow (a,b) \in \rho,$$

so that $\lambda_{\varphi} \subseteq \rho$.

We define a unitary congruence $\mu \in \text{Con } E\alpha$ in a similar way. By abuse of language, we shall say that $\vartheta \in \text{Con}^* S$ is *unitary* if both $\vartheta|_{\alpha E}$ and $\vartheta|_{E\alpha}$ are unitary. We shall denote by $\text{Con}_1^* S$ the set of unitary congruences on S.

If $\vartheta, \vartheta' \in \text{Con } S$ then it is clear that $(\vartheta \cap \vartheta')|_{\alpha E} = \vartheta|_{\alpha E} \cap \vartheta'|_{\alpha E}$. If now $(a, b) \in (\vartheta \lor \vartheta')|_{\alpha E}$ then there exist z_1, \ldots, z_n such that

$$a = z_1 = z_2 = \ldots = z_n = b$$

where each \equiv signifies either ϑ or ϑ' . It follows that

$$a = \alpha a \equiv \alpha z_1 \equiv \alpha z_2 \equiv \ldots \equiv \alpha z_n \equiv \alpha b = b$$

and therefore $(a, b) \in \vartheta|_{\alpha E} \vee \vartheta'|_{\alpha E}$. Hence we have that $(\vartheta \vee \vartheta')|_{\alpha E} \subseteq \vartheta|_{\alpha E} \vee \vartheta'|_{\alpha E}$, whence we have equality since the reverse inclusion is trivial. It now follows from the Corollary to Theorem 13 that Con^{*} S is a sublattice of Con^{*} S.

Observe that if $\Psi(\lambda, \vartheta, \mu) \in \operatorname{Con}^* S$ and $\varphi = \lambda|_{\alpha E \alpha} = \mu|_{\alpha E \alpha}$ then it follows from Theorem 14 that $\Psi(\lambda_{\varphi}, \vartheta, \mu_{\varphi}) \in \operatorname{Con}^*_1 S$ and the mapping $\Psi(\lambda, \vartheta, \mu) \mapsto \Psi(\lambda_{\varphi}, \vartheta, \mu_{\varphi})$ is a closure on Con* S.

Although a description of the lattice Con*S appears to be very difficult, we can describe the sublattice Con₁*S. For this purpose, we denote by Con $H_{\alpha} |\times|$ SpCon $\alpha E \alpha$ the set

$$\{(\vartheta, \varphi) \in \operatorname{Con} H_{\alpha} \times \operatorname{SpCon} \alpha E \alpha; \vartheta \subseteq \pi_{\lambda_{\alpha}, \mu_{\alpha}}\}.$$

THEOREM 15. $\operatorname{Con}_{1}^{*} S = \operatorname{Con} H_{\alpha} |\times| \operatorname{SpCon} \alpha E \alpha$.

Proof. For every $\varphi \in \text{SpCon } \alpha E \alpha$ we have, by Theorem 12 and the fact that $\lambda_{\varphi}, \mu_{\varphi}$ are unitary,

$$\Gamma^+(\varphi) = \Psi(\lambda_{\varphi}, \pi_{\lambda_{\varphi}, \mu_{\varphi}}, \mu_{\varphi}) \in \operatorname{Con}_1^* S.$$

It follows by Theorem 8 that for $(\vartheta, \varphi) \in \operatorname{Con} H_{\alpha} |\times| \operatorname{SpCon} \alpha E \alpha$ we have

$$\Psi(\lambda_{\omega}, \vartheta, \mu_{\omega}) \in \operatorname{Con}_{1}^{*} S.$$

We can therefore define a mapping $\zeta: \operatorname{Con} H_{\alpha} |\times| \operatorname{SpCon} \alpha E\alpha \to \operatorname{Con}_{1}^{*} S$ by the prescription

$$\zeta(\vartheta,\varphi)=\Psi(\lambda_{\varphi},\vartheta,\mu_{\varphi}).$$

Suppose now that $\Psi(\lambda, \vartheta, \mu) \in \operatorname{Con}_1^* S$. If $\varphi = \lambda|_{\alpha E \alpha} = \mu|_{\alpha E \alpha}$ then since λ and μ are unitary we have $\lambda = \lambda_{\alpha}$ and $\mu = \mu_{\alpha}$; for example, by Theorem 13,

$$(a,b) \in \lambda_{\varphi} \Leftrightarrow (a\alpha,b\alpha) \in \varphi = \lambda |_{\alpha E \alpha} \Leftrightarrow (a,b) \in \lambda.$$

Since $\vartheta \subseteq \pi_{\lambda,\mu} = \pi_{\lambda_{\varphi},\mu_{\varphi}}$ we therefore have $(\vartheta, \varphi) \in \operatorname{Con} H_{\alpha} |\times| \operatorname{SpCon} \alpha E \alpha$. Consequently we can define a mapping $\eta : \operatorname{Con}_{1}^{*} S \to \operatorname{Con} H_{\alpha} |\times| \operatorname{SpCon} \alpha E \alpha$ by the prescription

$$\eta \Psi(\lambda, \vartheta, \mu) = (\vartheta, \varphi).$$

Now each of ζ , η is isotone; and we have

$$\eta\zeta(\vartheta,\varphi) = \eta\Psi(\lambda_{\varphi},\vartheta,\mu_{\varphi}) = (\vartheta,\varphi);$$

$$\zeta \eta \Psi(\lambda, \vartheta, \mu) = \zeta(\vartheta, \varphi) = \Psi(\lambda_{\varphi}, \vartheta, \mu_{\varphi}) = \Psi(\lambda, \vartheta, \mu).$$

Thus η , ζ are mutually inverse isomorphisms.
