Julia Eichenberg is a post-doctoral research fellow at Trinity College Dublin. She completed her doctoral thesis in 2008 at the University of Tübingen on Polish veterans, their international contacts and pacifist activities in the inter-war period. Her current project compares paramilitary violence against civilians in Poland and Ireland in the aftermath of the Great War and during the establishment of independent states.

Robert Gerwarth is a lecturer in modern European history at University College Dublin. He is a specialist in the history of German and central European political culture in the period between 1871 and 1945.

Ryan Gingeras was awarded a Ph.D. by the University of Toronto for his thesis 'Sorrowful Shores: Violence, Ethnicity, and the End of the Ottoman Empire 1912–1923'. He is a specialist in the history of the modern Middle East, modern Turkey and the imperial borderlands.

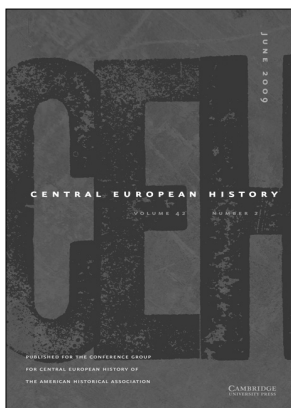
John Horne is Professor of Modern European History at Trinity College Dublin. He has published widely on war crimes and atrocities, especially during the First World War, and on cultural mobilisation and demobilisation.

Christian Kleinschmidt is Professor of Economic and Social History at Philipps-Universität Marburg. He has written widely on aspects of European economic history in the nineteenth and twentieth centuries. His most recent publications include *Konsumgesellschaft* (2008), *Technik und Wirtschaft im 19. und 20. Jahrhundert* (2006), and (editor) *Kuriosa der Wirtschafts-, Unternehmens- und Technikgeschichte* (2008).

John Paul Newman is an IRCHSS post-doctoral research fellow at the Centre for War Studies, University College Dublin. He works on the social and cultural history of the First Yugoslavia and south-eastern Europe more generally. He is currently preparing a monograph which focuses on the veterans of the Great War in the First Yugoslavia, looking at men who served in the Serbian, Montenegrin, and Habsburg armies and their attitudes towards each other, the South Slav state, politics and civil society in

the interwar period. His publications include ‘Silent Liquidation? Croatian Veterans and the Margins of War Memory in Interwar Yugoslavia’, in *Sacrifice and Rebirth: The Legacy of the Great War in East-Central Europe* (John Paul Newman, Mark Cornwall, eds.) (forthcoming, 2011), and ‘Forging a United Kingdom of Serbs, Croats, and Slovenes: The Legacy of the First World War and the “Invalid Question”’, in *Key Issues and Controversies* (Dejan Djokić and James Ker-Lindsay, eds.) (2010).

Joshua Sanborn is Professor of Russian and East European History at Lafayette College, and has published widely on the military, war and killing in Russian society. He currently works on his research project, ‘Life on the Frontier of Death: Soldiers, Civilians, and the Ecosystem of War in Russia, 1914–1918’.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor John Connelly, jfconnel@berkeley.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short description of work in progress and previously published work
