It consists of Ordinary and Honorary Members.

Candidates for admission as Ordinary Members are nominated at one ordinary meeting of the Society, and halloted for at the next, a majority of at least two-thirds of the members present being necessary for election.

All intending purchasers of the *Edinburgh Mathematical Notes* should apply to the Hon. Secretary. Certain volumes of the *Proceedings* are out of print or very scarce, and the Hon. Such gifts will be earmarked if desired for transmission to wardamaged libraries needing them.
