## **RESISTANCE AND REVOLUTION IN CHINA**

### **The Communists and the Second United Front**

*Tetsuya Kataoka*

The success of the Chinese Communist revolution is usually explained in Maoist terms as the result of a "peasant revolution." Thus, although Mao Tse-tung had developed an effective revolutionary strategy in Kiangsi, other "erring" leaders prevented him from implementing it; only with the defeat of the Red Army in 1934 was Mao vindicated.

Mr. Kataoka shows that, in reality, the Communist movement had been rurally oriented as early as 1928, and that the forced flight to Yen-an therefore constituted an indictment of "Maoism." Eventually Mao devised a successful strategy; by appealing to public opinion in the cities in order to force Chiang Kai-shek into war against Japan, the Communists caused him to abandon the civil war against them.

## **BACKWARD TOWARD REVOLUTION**

### **The Chinese Revolutionary Party**

*Edward Friedman*

Focusing on Sun Yat-sen and his Chinese Revolutionary Party after the failure of the republican revolution of 1911, Mr. Friedman tries to capture the subjective motivations of rural rebels and radical intellectuals. He believes that organizational secrets about discipline and unity were insufficient to fuse the explosive energies of the rural uprooted with the radical intelligentsia. He finds the source of that fusion instead in personal, familial, and religious crises that created new revolutionary ties. In short, he redefines the revolution to encompass the source of its energy—the values and beliefs of the revolutionaries themselves.

## **EMIGRATION AND THE CHINESE LINEAGE**

### **The *Mans* in Hong Kong and London**

*James L. Watson*

The main focus of this account of emigration and social change in Chinese peasant society is the largest "emigrant community" in the New Territories of Hong Kong. The inhabitants of this village live on remittances from restaurant workers in England and Holland. Like many other villages in South China, San Tin is inhabited by a single lineage: all of the males trace descent from a common ancestor and share the surname *Man*. The restaurant workers, in fact, have found the lineage to be very useful as the framework for an elaborate system of chain migration that extends halfway around the world.

The book should interest a broad spectrum of readers, for the migration patterns characteristic of San Tin resemble those found in emigrant communities all over the world.
