The Editorial Advisory Board of the *Business History Review* announces the winner of the 2010–2012 ALFRED AND FAY CHANDLER BOOK AWARD in BUSINESS HISTORY:

Michael B. Miller, *Europe and the Maritime World: A Twentieth-Century History* (New York, 2012)

The Chandler Book Award is given once every three years to the best work in the field of business history published in the United States, as determined by the Editorial Advisory Board of the *Business History Review*. The winner is presented with a certificate.

## HARVARD BUSINESS SCHOOL FELLOWSHIP AND GRANT.

### *Harvard-Newcomen Postdoctoral Fellowship in Business History.*

To be awarded for twelve months' residence, study, and research at Harvard Business School. The fellowship is open to scholars who, within the last ten years, have received a PhD in history, economics, or a related discipline. The fellowship has two purposes: The first is to enable scholars to engage in research that will benefit from the resources of Harvard Business School and the larger Boston scholarly community. The second is to provide an opportunity for the fellow to participate in the activities of Harvard Business School. The fellow is required to research and write a case, under the direction of a senior faculty member, to be used in one of the business history courses. A travel fund and a book fund will be provided. The fellowship will be awarded and all applicants notified by mid-January. Salary is competitive. The Fellowship will begin July 1.

Applicants should submit a CV, undergraduate transcript and graduate-school record, thesis abstract, and writing sample (such as an article or a book chapter). Applicants should also state the topics, objectives, and design for the specific research to be undertaken. Finally,

applicants should indicate the names of three people who will write references on their behalf. The three letters of recommendation are to be submitted by the writers directly by October 15 of the calendar year preceding that in which the fellowship is to be used. It is the responsibility of the applicant to solicit these letters. *The Alfred D. Chandler Jr. Travel Fellowships.* The Alfred D. Chandler Jr. Travel Fellowships facilitate library and archival research in business or economic history. Grants range from \$1000 to \$3000. Applicants must be 1) Harvard University graduate students in history, economics, or business administration, research requires travel to distant archives or repositories; 2) graduate students or nontenured faculty in those fields from other Universities—US and abroad—research requires travel to Baker Library and other local archives; or 3) Harvard College undergraduates writing senior theses in these fields, research requires travel away from Cambridge. Please send a CV, a 1-2 page summary of past academic research, a 2-3 page research proposal—include amount of grant required, and one letter of reference to Walter A. Friedman, Connell 301A, Harvard Business School, Boston, MA 02163. E-mail: [wfriedman@hbs.edu](mailto:wfriedman@hbs.edu) by November 1 of the year preceding the year the Fellowship is to be used. #### HAGLEY MUSEUM AND LIBRARY GRANTS.

*Hagley Exploratory Research Grants.* These grants support one-week visits by scholars who believe that their project will benefit from Hagley research collections, but need the opportunity to explore them on-site to determine if a Henry Belin du Pont research grant application is warranted. Priority will be given to junior scholars with innovative projects that seek to expand on existing scholarship. Applicants should reside more than 50 miles from Hagley, and the stipend is \$400. Application deadlines: March 31, June 30, and October 31.

*Henry Belin du Pont Fellowships.* These research grants enable scholars to pursue advanced research and study in the collections of the Hagley Library. They are awarded for the length of time needed to make use of Hagley collections for a specific project. The stipends are for a maximum of eight weeks and are prorated at \$400/week for recipients who reside further than 50 miles from Hagley, and \$200/week for those within 50 miles. Application deadlines: March 31, June 30, and October 31.

**HUNTINGTON LIBRARY FELLOWSHIPS.** The Huntington is an independent research center with extensive holdings in British and American history, literature, art history, and the history of science and medicine, with the collections ranging chronologically from the eleventh century to the present. The Huntington will award to scholars over one hundred fellowships for the academic year 2014–2015. These fellowships derive from a variety of funding sources and have different terms. Recipients of all fellowships are expected to be in continuous residence at the Huntington and to participate in and make a contribution to its intellectual life.

*Neh Fellowships* offer stipends of up to \$50,000 for nine to twelve months.

*Barbara Thom Postdoctoral Fellowships* are intended to support a non-tenured faculty member who is revising a manuscript for publication, carrying a stipend of \$50,000 for nine to twelve months.

*The Mellon Fellowship* is for nine to twelve months with a stipend of \$50,000.

*The Dana and David Dornsife Fellowship* is for nine to twelve months with a stipend of \$50,000.

*Huntington Research Awards* are for one to five months and carry monthly stipends of \$3,000.

*Travel Grants and Exchange Fellowships for Study in Great Britain* are offered to support US-based scholars in any of the fields in which the Huntington collections are strong and where the research will be carried out in Great Britain. We also offer exchange fellowships with Corpus Christi College, Linacre College, and Lincoln College, Oxford.

*The Dibner Program in the History of Science* offers historians of science and technology the opportunity to study in the Burndy Library and to work in the other resources for the history of science and technology at the Huntington. Both long- and short-term fellowships are available.

HENCH POST-DISSERTATION FELLOWSHIP AT THE AMERICAN ANTIQUARIAN SOCIETY. Application materials are now available for the 2014–15 Hench Post-Dissertation Fellowship at the American Antiquarian Society. Scholars who are no more than three years beyond receipt of the doctorate are eligible to apply for this year-long residential fellowship at the American Antiquarian Society (located in Worcester, MA) to revise their dissertation for publication. The purpose of the Hench Fellowship is to provide the recipient with time and resources to

extend research and/or to revise the dissertation for publication. Any topic relevant to the Society's library collections and programmatic scope—that is, American history and culture through 1876—is eligible.

**WARREN CENTER FELLOWSHIP.** Harvard University's Charles Warren Center Seminar seeks applications for a year-long faculty fellowship and workshop, "Multimedia History and Literature: New Directions in Scholarly Design," on the analysis and presentation of multimedia history and literature. The digital revolution presents challenges and opportunities to customary ways of conducting research, presenting findings, storytelling, and reading. Historical and literary scholarship can now include open-ended and multiform engagements that invite us to reconsider how history and literature have been, could be, and should be represented.

Applicants may not be degree candidates and should have a PhD or equivalent. (Typically these are faculty fellowships, though may be held by those without a tenure-track position.) Fellows have library privileges and an office which they must use for at least the 9-month academic year. Fellows will participate in a seminar led by Vincent Brown (Departments of History and African and African American Studies) and Glenda Carpio (Departments of English and African and African American Studies). Stipends: individually determined according to fellow needs and Center resources, up to a maximum of \$54,000, without benefits. **BUSINESS HISTORY EXPLORER.** BHE is an online bibliography of publications on the history of specific businesses and industries operating in England, Scotland, Wales and Northern Ireland. It also covers the international activities of those businesses, especially in former British dominions and colonies, and in North America, Latin America, China and Japan. It has been developed by John Orbell with Richard Storey and Francis Goodall. BHE enables users to locate historical information on 12,000 businesses or industries held in around 24,000 monographs, chapters in multi-author works, theses and unpublished essays and manuscripts. Periodical articles will be included in subsequent releases.

Available with BHE is a 300-page publication which provides summary details, arranged in alphabetical order of business, industry or subject name, of each publication in the bibliography. IN MEMORIUM: FRANCESCA CARNEVALI (1964–2013). We are saddened by the recent death of Francesca Carnevali, business historian in the Department of History at the University of Birmingham. Francesca was born in Italy and earned her PhD from the London School of Economics, joining Birmingham in 1996. She was a well-loved member of the Department and will be greatly missed by her numerous friends and colleagues.

Francesca's academic interests ranged from banks to jewelry. Her publications include *Europe's Advantage: Banks and Small Firms in Britain, France, Germany, and Italy since 1918* (2005); "Social Capital and Trade Associations in America, c.1860–1914: A Microhistory Approach," *Economic History Review* 64, no. 3 (2011); and "Fashioning Luxury for Factory Girls: American Jewelry, 1860–1914," *Business History Review* 85, no. 2 (2011). Her most recent work was a collaboration with Lucy Newton, "Pianos for the People: From Producer to Consumer in Britain, 1851–1914," *Enterprise and Society* 14, no. 1 (2013). In her *BHR* article, part of a special issue on creative industries, Francesca explored the democratization of luxury goods in the nineteenth century by focusing on the Rhode Island jewelry industry. Jewelry, once hand-crafted and available only to the elite, became an industrial product that was marketed through magazines and mail order catalogues to all segments of society, at different price levels and in a dizzying array of design choices. She was working on a book-length treatment of this subject for Harvard University Press at the time of her death.

She was an active member of the business history community, serving as Chair of the Women's Committee of the Economic History Society and organizing the 2002 conference of the Economic History Association as well as the 2008 conference of the Association of Business Historians. She was also Reviews Editor of the *Economic History Review* and was former Associate Editor of *Enterprise and Society*.

Francesca is survived by her husband Paolo Di Martino, also a business historian at the University of Birmingham, and her mother and brother.
