Federal Executives Win Congressional Fellowships

The Association also selected 22 federal executives as Congressional Fellows in a national competition for the 1991-92 program and expects to name approximately three more before September.

The recipients—advanced career civil servants—will serve as professional staff assistants to U.S. senators and representatives for nine months. They are scheduled to arrive here early in November for an orientation period before beginning work in Congressional offices of their choice. The program will conclude in August, 1992.

Of the 22 federal executives, seven have been named Foreign Affairs Fellows and will participate in a special two-month seminar on Congress and Foreign Policy. This course is taught by Professor Frederick Holborn at the Paul H. Nitze School of Advanced International Studies (The Johns Hopkins University), prior to the beginning of orientation. Foreign Affairs Fellows are federal executives who serve in foreign policy positions in their agencies.

The 1,397 alumni of the program include: high ranking executives of the federal bureaucracy, congressional staff aides, newspaper publishers, editors and reporters, university presidents, deans and faculty.
