ESSAY REVIEWS

#### THE SINGER PRIZE

The British Society for the History of Science has established the Singer Prize, to be awarded every two years for an unpublished essay based on original research on any aspect of the history of science, including mathematics. Professor Charles Singer (1876–1960), the distinguished historian of science and medicine, was a founder-member, and the first President of the Society. The prize consists of one hundred pounds.

The competition is open to anyone with a scholarly interest in the history of science who shall not have reached 30 years of age by the closing date, 30 September 1980. Full or student members of the Society from any country may enter the competition (membership details on inside back cover of this *Journal*). Essays must be submitted in English, typewritten and double-spaced on one side of the paper. Essays should not exceed 6,000 words in length (excluding footnotes), and must be fully documented following the conventions used by the *British journal*, but this cannot be guaranteed.

All entries should be sent to the Hon. Secretary of the Society, Dr W. F. Bynum, Wellcome Institute for the History of Medicine, 183 Euston Road, London NWI 2BP, with the words 'Singer Prize' clearly written on the envelope. Each entry should contain a separate title-page giving the author's name, title of essay, institution (if any), address, and date of birth, so that this information can be removed before the essay is circulated to the judges. Essays (only one from each competitor) must be received no later than 30 September 1980.

The decision of the judges appointed by the Council of the British Society for the History of Science will be final. The Society reserves the right to divide the prize between two or more competitors of equal merit, or not to award a prize should no essay be deemed of a suitable standard. All competitors will be notified of the winner's name by post. Manuscripts will not be returned unless appropriate return postage is submitted with the entry. Public announcement of the award-winning essay will be made at the Society's Annual General Meeting, and in the Society's *Journal* and *Newsletter*.
