
Notes on Contributors

Peter Yding Brunbech is a former postdoctoral fellow at the Department of History and Area Studies, Aarhus University. His main and current research field is Danish contemporary political history with a special emphasis on foreign aid policy. His Ph.D. dissertation, *Dansk udviklingspolitik 1949–71 – en analyse af den tidlige udviklings- og bistandspolitik over for ulandene og dens funktion i dansk udenrigspolitik* (2007), was the first major historical analysis of Danish cold war development assistance policy in thirty years. He has published a number of articles (primarily in Danish) on Danish development assistance policy from 1945 to 1992.

Marc Frey holds the Helmut Schmidt Chair of International History at Jacobs University, Bremen. He has published widely on European colonialism and decolonisation, on the international politics of southeast Asia and the Vietnam war, American foreign relations in the twentieth century and on the history of development policies and development co-operation. His publications include *Dekolonisierung in Südostasien. Die Vereinigten Staaten und die Auflösung der europäischen Kolonialreiche, 1930–1961* (Munich: Oldenbourg, 2006); *Geschichte des Vietnamkriegs* (Munich: C.H. Beck, 1998), of which the 8th edition was published in 2006; *Der Erste Weltkrieg und die Niederlande. Ein neutraler Staat im politischen und wirtschaftlichen Kalkül der Großmächte* (Berlin: Akademie Verlag, 1998); as well as *The Transformation of Southeast Asia: International Perspectives on Decolonization* (Armonk, NY: M. E. Sharpe, 2004), edited with Ronald W. Pruessen and Tan Tai Yong.

Julie Gottlieb is a lecturer in Modern History at the University of Sheffield. She has published widely on the topic of gender and fascism in Britain, and is the author of *Feminine Fascism: Women in Britain's Fascist Movement, 1923–1945* (London: I. B. Tauris, hardback 2000, paperback 2003), and two edited books: *The Culture of Fascism* (London: I. B. Tauris, 2004), co-edited with Thomas Linehan, and *Making Reputations* (London: I. B. Tauris, 2005), co-edited with Richard Toyne. Her current research project is called 'Guilty Women: Gender and Appeasement in Inter-war Britain'.

Uta Hinz is a researcher with the Max Weber project at Heinrich-Heine University, Düsseldorf, Germany. Originally a historian of prisoners of war during and after the First World War, her first book, the published version of her Freiburg Ph.D. dissertation, is *Gefangen im Großen Krieg. Kriegsgefangenschaft in Deutschland 1914–1921* (Essen: Klarex, 2006). She is currently involved with editing Max Weber's letters from 1918 to 1920 for Weber's complete works and is also working on her habilitation project that addresses the status of the memory of war, peace and nation in the protest cultures of the Federal Republic of Germany.

Sönke Kunkel is a Ph.D. candidate at Jacobs University, Bremen. He is working under Marc Frey's supervision on a thesis that investigates the shift in the mechanics of the global American empire by drawing from approaches that have been hotly debated in other fields, but have largely been ignored by international and global historians: performance studies, visual history, emotional history, and symbol theories. He is also interested in the history of international organisations (INGOs), globalisation and global governance, in particular in how the United Nations Conference on Trade and Development, INGOs such as OXFAM and the United Nations Secretariat intended to establish a structure of global governance that would regulate globalisation for the sake of development between 1964 and 1980. He has already published a number of articles on these topics as well as on German history. He is currently co-editing a book (together with Christoph Meyer) on 'Decentering Europe: A Global History of the Interwar Years, 1919–1939'.

Sabine Lee is Reader of Modern History at the Department of Modern History at the University of Birmingham. She graduated with a degree in Mathematics and History from Düsseldorf University before completing an M.Phil. in International Relations at Cambridge University and a Ph.D. in Modern History at Cambridge University. Her recent publications include *Sir Rudolf Peierls – Selected Private and Scientific Correspondence*, two volumes (2007 and 2009); *The Bethe-Peierls Correspondence* (2007) and *The Nucleon–Nucleon Interaction and the Nuclear Many-Body Problem* (2010), co-edited with G. E. Brown, T. T. S. Kuo and J. W. Holt, 2010; as well as *Historical Social Research Focus Issue: Children Born of War. Second World War and Beyond*, 34 (2009).

Barbara Lüthi is senior lecturer and research scholar at the History Department, University of Basel (Switzerland). Her main interests are in the fields of migration history, US social and cultural history, global history and postcolonial studies. Recent publications include: *Invading Bodies. Medizin und Immigration in den USA (1880–1920)* (Frankfurt/Main and New York: Campus, 2009); *Zum Fall machen, zum Fall werden. Wissensproduktion und Patientenerfahrung in Medizin und Psychiatrie des 19. und 20. Jahrhunderts* (Frankfurt/Main and New York: Campus, 2009), co-edited with Sibylle Brändli and Gregor Spuhler.

Sotiris Rizas is Director of Research at the Research Centre for the Study of Modern Greek History/Academy of Athens. His research interests include Greek foreign

policy in the twentieth century and the impact of the cold war on domestic politics and foreign policies. Among his books in Greek are: *The United States, the Dictatorship and the Cypriot Question, 1967–1974* (Athens, 2002); *Greek Politics After the Civil War* (Athens, 2008). His articles in English include: ‘The Greek Military Regime’s Policy Towards Cyprus, 1967–1974’, *Modern Greek Studies Yearbook*, University of Minnesota, volume 18–19, 2002–2003, 239–52; ‘Atlanticism and Europeanism in Greek Foreign and Security Policy’, *Journal of Southeast European and Black Sea Studies*, 8, 1 (spring 2008), 51–66; ‘Managing a Conflict Between Allies: United States Policy Towards Greece and Turkey in Relation to the Aegean Dispute 1974–1976’, *Cold War History*, 9, 3 (2009), 367–87.

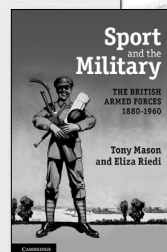

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short description of work in progress and previously published work
