THE publishers of *Medical History* are offering a Prize of £25 for the best essay on any aspect of the history of medicine.

The essay competition is open to all registered subscribers to *Medical History*, medical or lay, and wherever resident.

Essays submitted should be between 4,000 and 8,000 words in length, and should be typewritten on one side of the paper, with double spacing. They must be in the English language.

The Editor shall have the option of publishing the winning essay, and any of the other essays submitted, in *Medical History*.

The essays will be judged, and the prizewinner selected, by the following panel: Dr. William Brockbank, Sir Zachary Cope and Dr. F. N. L. Poynter.

In order to meet the convenience of intending competitors resident abroad it has been decided that the closing date for the submission of essays will be 31 December 1958, and not, as originally announced, 1 October 1958.

In accordance with the rules governing the majority of competitions of this kind, it is intended to preserve the anonymity of the competitors until the prizewinning essay has been selected by the judges. To this end, all candidates are required to follow these directions:

- I Every essay is to be signed with a pseudonym (e.g. 'Hopeful' or some such word) and it must bear no address or other distinguishing mark of any kind.
