Special chapters are devoted to indebtedness, the least-developed countries, aid to education, rural development, and technical co-operation and environment. The report also contains statistics on development assistance, export credits, private investment and indebtedness in developing countries.

## EXPENDITURE TRENDS IN OECD COUNTRIES, 1960-1980.

An analysis of the trends in the different categories or national expenditure within OECD countries. In addition, the report considers how different categories of expenditure have been financed. It emphasizes the relative trends in these methods of finance, especially the decline in the share of private consumption in GNP financed from the disposable part of a household's "primary" income. By contrast, consumption financed through government transfers has been relatively increasing. The likely continuation of these trends may have considerable bearing on future economic policy.

## SOCIAL BACKGROUND AND EDUCATIONAL CAREER, by Torsten Husén

This monograph brings together the main body of research results (hitherto widely scattered) on the relationship between social background on the one hand and educational opportunity and attainment on the other. Most of the evidence is provided by studies made in England, Scotland, the United States, Sweden and the Federal Republic of Germany.

The book argues that schools everywhere could do better than at present in providing more equal opportunity for the entry and advancement of pupils and it indicates the measures that are likely to bring about improvement. Professor Husén's compelling conclusion is that a new relationship between education, work and leisure must be found. One of the keys to this might well be adoption of a system of "recurrent education" whereby an alternation between work and further study would be made possible for everyone at any time in life.

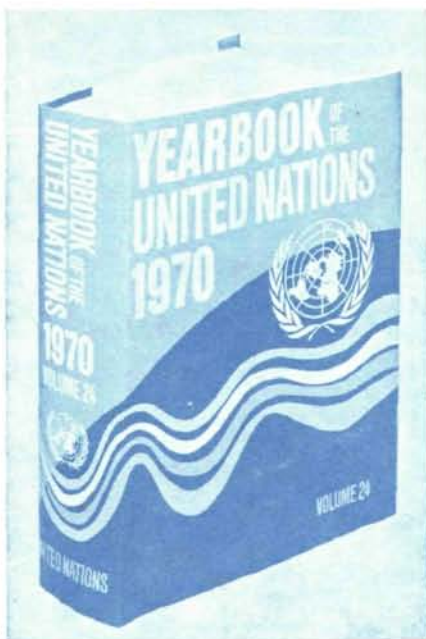
