THE KURBSKII-GROZNYI APOCRYPHA

The Seventeenth-Century Genesis of the "Correspondence" Attributed to Prince A. M. Kurbskii and Tsar Ivan IV

For centuries the exchange of letters between Ivan the Terrible and Prince Kurbskii has been considered an important source for sixteenth-century Russian history. But the provenance of the "Correspondence" has never been properly established. Mr. Keenan contends that this "Correspondence" is a forgery composed in the seventeenth century.
