# THE CONTRIBUTORS

ZBIGNIEW K. BRZEZINSKI, Associate Professor of Public Law and Government at the Russian Institute of Columbia University, is the author of *The Soviet Bloc: Unity and Conflict* (1960) and other books and articles on Soviet affairs.

ROBERT VINCENT DANIELS is Assistant Professor of History at the University of Vermont. His publications include A Documentary History of Communism (1960), The Conscience of the Revolution: Communist Opposition in Soviet Russia (1960), and The Nature of Communism, which will appear later in 1961.

LINCOLN GORDON is Professor of International Economic Relations at the Harvard Graduate School of Business Administration. From 1947 to 1955, he served in various official positions concerned with the Marshall Plan, NATO, and mutual security problems, and in 1957 edited the American Assembly volume, *International Stability and Progress*.

OTTO KIRCHHEIMER is Professor of Political Science on the Graduate Faculty of the New School for Social Research in New York and Visiting Professor in the Department of Public Law at Columbia University. His book on *Political Justice* is scheduled for publication in September 1961.

KARL W. DEUTSCH is Professor of Political Science at Yale University and Visiting Professor in the Political Science Section at M.I.T. Co-author with Lewis J. Edinger of *Germany Rejoins the Powers* (1959), he has a new book entitled *Backgrounds to Community* coming out later this year.

ALEXANDER ECKSTEIN, Haloid-Xerox Professor of International Economics at the University of Rochester, has recently completed *The National Income of Communist China*, to be published in May. He is now engaged in a study of rates and patterns of industrial growth in Communist China and in one concerning economic fluctuations in centrally planned economies.

RICHARD C. SNYDER, Professor and Chairman of the Department of Political Science at Northwestern University, is also Co-director of the Graduate Program of Training and Research in International Relations at that university and a member of the editorial board of the *Journal of Conflict Resolution*.

PAUL KECSKEMETI, Senior Research Associate of The RAND Corporation, formerly served as a regional analyst in the Office of War Information and the War Department. He is the author of *Strategic Surrender* (1958).

ARNOLD L. HORELICK is a staff member of the Social Science Division of The RAND Corporation, currently engaged in research on Soviet foreign policy and military affairs.

IMANUEL WEXLER, a former research assistant in the Harvard Economic Research Project, is now Instructor of Economics at the University of Connecticut in Hartford. He is at work on a study concerning development lending.
