# INSTRUCTIONS TO CONTRIBUTORS

The American Political Science Review aims to publish scholarly research and writing of exceptional merit. Contributions must demonstrate the highest standards of excellence in conceptualization, exposition, methodology, and craftsmanship. Because the Review reaches a diverse audience of scholars and practitioners, contributors must demonstrate how their analysis or exposition illuminates a significant research problem, or answers an important research question, of general interest in political science.

# **Article Manuscripts**

Manuscripts being submitted for publication should be sent to Professor Ada W. Finifter, Editor, *American Political Science Review*, Department of Political Science, Michigan State University, 303 South Kedzie Hall, East Lansing, MI 48824-1032. Correspondence concerning manuscripts under review may be sent to the same address or, preferably, by e-mail to apsr@ssc.msu.edu.

In general, manuscripts should be no longer than 35 pages including all tables, references, notes, and appendices, and should use at least 10 point size type. All pages must be numbered. Papers must be double-spaced, be printed on one side of the paper only, and include an abstract of no more than 150 words. The *American Political Science Review* style of embedded citations should be used, and there should be a separate list of references at the end of the article. Please do not use footnotes for simple citations. Papers not adhering to these guidelines are subject to being returned without review.

The American Political Science Review citation format will soon change to require inclusion of month, season, or issue number as part of the volume and page identification. All manuscripts submitted for publication should now contain this information. For example, a reference to an article in the Review would be given as 89(March):1–9, rather than 89:1–9. If a journal being cited does not use month or season, please substitute the issue number. On other questions of form, please follow the example of a recent issue of the Review.

For purposes of the *initial* submission, authors who wish to do so may place footnotes at the bottom of the pages instead of using endnotes and may locate tables and graphs (on separate pages and only one to a page) approximately where they fall in the text. However, manuscripts invited for resubmission or accepted for publication must be submitted with endnotes, tables, and graphs on separate pages at the back of the manuscript with standard indications of text placement, e.g., [Table 3 about here]. Please consider the necessity of making these changes on resubmission or acceptance of your paper in deciding how to format your initial submission.

For manuscripts that contain quantitative evidence and analysis, authors should describe their empirical procedures in sufficient detail to permit reviewers to understand and evaluate what has been done and, in the event the article is accepted for publication, to permit other scholars to carry out similar analyses on other data sets. As part of the review process, authors may be asked to submit additional documentation if procedures are not sufficiently clear.

The *Review* does not consider papers submitted to other journals or to publishers as part of a larger manuscript. Moreover, since space is at a premium, submission of articles substantially similar to articles submitted or published elsewhere, or to part of a book or other larger work, is discouraged. Authors should discuss any such related publications in a cover letter to the Editor.

Please follow these procedures for submission:

 Submit five copies of manuscripts, four of which should have no identifying references. The first page of the four anonymous copies should contain only the title and an abstract of no more than 150 words. No copies will be returned.

- The first page of the identified copy should contain the name, academic rank, institutional affiliation, and contact information (address, telephone, fax, e-mail) for all authors and, in the case of multiple authors, an indication of the author who will receive correspondence.
- 3. Please also send a *loose copy* of a page containing the full title of the article, the names of all authors, and the abstract.
- 4. Authors having access to e-mail should send a copy of the abstract to apsr@ssc.msu.edu, when the submission is mailed. The subject line should contain the first listed author's last name followed by the word "Abstract." The body of the message should contain the title of the paper, the names of all authors, and the abstract (as on the loose page described above). E-mail submission of the abstract is not required but will be helpful.
- Authors should not fax abstracts, send any part of the paper itself by e-mail, or send the abstract by e-mail before their submission packet is in the mail.

Since these procedures may be modified in the future, authors are encouraged to consult the most recent issue for the current instructions to contributors.

For matters not covered here, please refer to the *Style Manual* for *Political Science*, a publication of the American Political Science Association's Committee on Publications. It is available from the Association's office. Otherwise, authors should follow the *Chicago Style Manual* and the example of recent issues of the *Review*.

## **Book Reviews**

All book review correspondence should be sent to the Book Review Editor, Professor Mark Lichbach, *American Political Science Review* Book Review, Department of Political Science, University of Colorado, Box 333, Boulder, CO 80309. Authors wishing their book to be considered for review should ask their publisher to send a copy to the Book Review Editor. Those interested in reviewing books should send their vita to the Book Review Editor.

## Other Correspondence

Information, including news and notes, for the Association's news journal *PS*, should be sent to Dr. Robert J-P.
