Michael Burden is Professor in Opera Studies at University of Oxford, and is Fellow in Music at New College, where he is also Dean. His published research is on the theatre music of Henry Purcell, on the staging of opera and dance in London in the seventeenth, eighteenth and nineteenth centuries, and the administration of the Pyne-Harrison and English Opera Companies. His study of the soprano Regina Mingotti's London years is forthcoming. He is President of the British Society for 18th-century Studies, a Visitor to the Ashmolean Museum, Oxford, a trustee of RISM, and director of productions of New Chamber Opera, www.newchamberopera.co.uk. He organises the annual Oxford Dance Sympoisum with Jennifer Thorp, with whom he co-edited the *Ballet de la Nuit* in 2010.

Robert A. Green is Professor Emeritus, Northern Illinois University and is currently affiliated with the musicology department at Indiana University. He has published articles on French music and performance practice in many journals and a book, *The Hurdy-Gurdy in Eighteenth-Century France* (Indiana University Press, 1995), and has released two recordings of French Baroque hurdy-gurdy music. He is the editor of the *Journal of the Viola da Gamba Society of America*.

Sean M. Parr is Assistant Professor of Musicology at Saint Anselm College. Prior to this appointment, he taught music history and directed the Collegium Musicum at both Dickinson College and Columbia University, where he earned his Ph.D. in 2009. He is currently working on a monograph that explores coloratura and female vocality during the Second Empire.

Ben Winters is Lecturer in Music at the Open University. He is the author of *Erich Wolfgang Korngold's* The Adventures of Robin Hood: A Film Score Guide (Scarecrow Press, 2007), and his research on film music has appeared in journals such as *Music & Letters, Music, Sound, and the Moving Image*, and the *Journal of the Royal Musical Association*.
